Germany after Other Debts in South America. Brazil and Colombia Next to Feel Pressure of the Kaiser's Mailed Hand.

BERLIN, Feb. 17.—Germany, has no intention of withdrawing or reducing her fleet in South American waters with the abandonment of the Venezuelan blockade...

Barely have the clouds of the Venezuelan affairs passed away when another rises in the form of German demands upon Colombia, which may bring about special complications owing to the negotiations for the construction of the Panama canal by the United States.

Germany is prone to regard with jealous eyes the possession of the Panama canal route by the United States, and fears the successful commercial competition of the Americans when that waterway is controlled and completed by the Washington government.

Instead of modifying its aggressive South American policy the German government proposes to make it still more vigorous. In an interview an official of the foreign office spoke frankly of the intentions of Germany toward South American countries, and said that the Germans believe the demonstration against Venezuela has effectively proven to other South American countries that the Monroe Doctrine offers them no protection against the payment of debts, and that it is the intention of the German government to make these South American countries pay up.

How To Beat Rugs.

Much Wasted Energy in the Ordinary Method of Doing the Job.

An amusing example of wasted energy is generally exhibited when the man-of-all-work beats the rugs at home cleaning time. The rug is hung over a clothesline in such a manner that most of the dust beaten out of one part enters the other.

This unorthodox method may be abolished and the rugs cleaned in much less time and in a more thorough manner if a frame is used. It is simple in construction, costs little, and is out of the way when not in use.

A double pulley carrying an inch hempen rope enables one man to raise and lower it with ease. But one cross bar is used, it being at the lower end, and as the wire netting is not carried beyond it there is ample space to reach a large rug from all sides.

When beating a rug on it the pile side should be underneath.

Identified by Dying Sister. General Nell Who Is Charged With Killing His Mother.

PHILADELPHIA, February 16.—George Nell, who was captured in Reading last night and to-day brought to Philadelphia, has been positively identified by his dying sister as the slayer of his mother. Shortly after his arrival here, handcuffed to a detective, Nell was taken to the Germantown hospital, and standing by the bedside of Minnie Nell, whom he assaulted with the same hatchet used to kill his mother, the prisoner was identified by the sister. In answer to his question as to whether he had killed his mother and murdered her sister, Miss Nell said: "Yes, George you did it. You know you did it."

This afternoon Nell was given a hearing at the city hall, and committed to await the action of the coroner. A special coroner inquest will be held to-morrow, and the authorities mean to see that the law works rapidly in Nell's case.

Congress Gallery in Blaze. Flooring Ignited From Defective Plug, but Little Damage Done.

WASHINGTON, Feb. 17.—Some little excitement was created in the House of Representatives just before that body convened to-day by the discovery of a slight blaze in the flooring of the east reserved gallery.

The doorkeepers and attendants rushed into the gallery and the blaze was soon extinguished. A few wisps of smoke which arose from the fire filled the hall with the odor of burning wood, but otherwise the members suffered no inconvenience when the House met a few minutes later at noon.

Children Dead; Mother Missing. Two children, one 2 and the other 4 years of age, are dead at Davy, a small village near Welch, W. Va. The authorities are searching for their mother, Mrs. Walter Dykes.

Mrs. Dykes and her husband had separated. Each wanted the children, but the woman succeeded in getting possession of them, and Sunday evening looked them in an upstairs room. Monday morning both children were found dead and the mother could not be located.

Valued His Throat at \$5,000. George W. Overhiner, a farmer of Madison county, O., has disclaimed his suit against his sister, Mrs. Laura J. Hooser, for \$5,000 damages, because she gave him a remedy to cure him of the liquor habit.

In the complaint, filed last fall, it was alleged that the defendant had administered to the plaintiff a chemical preparation to his coffee, and that it was due to this knowledge of his death was accidental. He had been wanted by the police on a charge of bigamy, but would have been held pending further developments in the case of Miss Curry.

Both Bernard and Miss Curry resided at La Motte, a suburb of this city. Thursday night the young woman was found unconscious and bleeding from wounds in the head and neck near her home and died later at a hospital. She had alighted from a trolley car a short time before she was thus discovered and is known to have been followed by a man resembling Bernard.

Leo XIII Opens Gates of Vatican to Poor. ROME, Feb. 22.—This was a great day for the poor of Rome, a thousand of them being the guests of the Pope at a dinner in the Belvedere Court of the Vatican, in honor of the pontiff's jubilee.

The guests were waited upon by nuns, and the Swiss Guards, in brilliant uniforms, kept order, their band playing through the repast. The excellent bill of fare included wine and dessert.

Great enthusiasm was displayed, and there were repeated cries of "Long live Pope Leo!"

The Pope desired personally to administer his blessing on the gathering; but, although he was well, the doctors vetoed his desire, in order that he might husband his strength for the coming functions of his jubilee.

Woman 80 Years Old Cuts New Set of Teeth. Small White Ones Replace Those Lost by Mrs. Ver House Many Years Ago.

Mrs. Abram Ver Howes, 80 years old, of Williamsport, is cutting a new set of teeth. About two weeks ago she was troubled with soreness and inflammation of the gums. She had lost all her teeth years ago.

Younger is broken in health, his nerve is gone, he is penniless, and at the age of fifty-nine was trying to begin life over again, without much show of success. He was unable to secure work and drifted about. He would have made a good living but for a clause in his pardon prohibiting him from going on the stage.

The little girl in running down the hill above the ovens fell and rolled into one of the hot ovens. Men at work nearby broke into the oven and scoured the body, but it was burned to a crisp, hardly the semblance of a human form being left.
