The governor, while presiding over the meetings of the board when contracts for "furnishings" were let, was surely not so unsophisticated as not to know that the extra millions were being abstracted from the banks for "furniture" without the knowledge of the people. There being no special appropriation for the purpose, and the money simply having been scooped out of the enormous surplus at the pleasure of the poard, leaving ten milloins, more or less. in the depositories all the while, the people could not have known anything about the matter until the honest, vigilant State Treasurer Berry exposed it. 
STUART ALWAYS DODGED

Candidate For Governor Non-Committal On Vital Issues When He Was Councilman.

This is a new chapter of the delinquencies of the Republican nominee for governor, Edwin S. Stuart, during his five years' membership in the select council of Philadelphia.
