

Receipts and Expenditures OF CENTRE COUNTY FOR 1908.

To the Honorable, the Judge of the Court of Common Pleas of Centre County, State of Pennsylvania:

The Board of County Auditors, H. B. Pontius of Bellefonte Borough, R. D. Musser, of Gregg township, and J. W. Beck, of Howard Borough, met at the Court House January 4th, 1909, according to Act of Assembly of the 21st day of April, 1903, to audit the accounts of the different officials of the county for the year 1908. Written notices were served on them to deliver to the board all books and papers pertaining to their respective offices for examination and audit. We therefore submit the following report to wit: The accounts of John L. Dunlap, Calvin A. Weaver and John G. Bailey, County Commissioners; Frank K. White, County Treasurer; A. B. Kimport, Prothonotary and Henry Kline, High Sheriff, were examined and found to be correct. And that the books of the Commissioners show an expenditure of one hundred and thirteen thousand seven hundred and eighty-eight and two one hundredths dollars (\$137,888.02) paid out during the year 1908. The account of Frank K. White, County Treasurer, was carefully examined and compared with the vouchers and were found to be correct. And that the receipts of the office exceeded the expenditures leaving in the hands of the Treasurer a balance of two thousand nine hundred and thirty-nine and eighteen one-hundredths dollars (\$2,939.18) due the county. We also find there was collected during the year the amount of sixteen thousand six hundred and ninety-five and fifteen one-hundredths dollars (\$16,696.10) arising from unseated lands and paid out to the different townships for Road, School and Poor purposes. We find in the hands of the Treasurer a balance of sheep funds of three thousand nine hundred and sixty-nine and thirty-one hundredths dollars (\$3,969.31) arising from Dog Tax. We find there was collected during the year 1908, one thousand and eighty-three and ten one-hundredths dollars (\$1,083.10) arising from Liquor Licenses for 1909 and part of 1909, and was paid out to the different Boroughs and Townships. Upon examination of the bill of fees, costs, etc., of A. B. Kimport, Prothonotary, we find him due from the county the sum of one hundred and fifty-nine and six-tenths dollars (\$159.64). The account of Henry Kline, Sheriff, was carefully examined and found to be correct and that there is due him from the county the sum of three thousand three hundred and eighty-six and six-tenths one-hundredths dollars (\$3,386.61).
