

Receipts and Expenditures

OF

CENTRE COUNTY FOR 1910

To the Honorable Ellis L. Orvis, Judge of the Court of Common Pleas of Centre County, Pennsylvania:

The Board of County Auditors, H. B. Pontius, of Bellefonte Borough, R. D. Musser, of Gregg Township, and C. U. Hoffer, of Phillipsburg Borough, met at the Court House, January 2nd, 1911, in accordance with the provisions of the Act of Assembly in such cases made and provided, to audit the accounts of the various officials of the County for the year 1910.

Written notices were served on the County Commissioners, County Treasurer, Prothonotary and Sheriff to deliver all books and vouchers pertaining to their respective offices for examination and audit.

The books of the County Commissioners show an expenditure of One Hundred and Seventy-eight Thousand Six Hundred and Thirty-nine and 05/100 dollars (\$178,639.06) paid out during the year 1910. The accounts of G. G. Fink, County Treasurer, were carefully examined and checked with vouchers and found to be correct, and the receipts of the office covered the expenditures, leaving in the hands of the Treasurer a balance of Three Thousand Eight Hundred and Sixty and 95/100 dollars (\$3,869.95) due the County.

We also find there was collected during the year the amount of Fourteen Thousand Two Hundred and Seventy-four and 64/100 dollars (\$14,274.64), arising from Unseated Land Taxes and paid out to the different Townships for Road, Poor and School purposes.

We find in the hands of the Treasurer a balance of sheep funds of Three Thousand Five Hundred and Forty-three and 22/100 dollars (\$3,543.22), arising from Dog Tax. We find there was collected during the year 1910 Two Thousand Seven Hundred dollars (\$2,700.00), arising from Liquor License, and was paid out to the different Boroughs and Townships.

Upon examination of bill of fees, costs, etc., of A. B. Kimpfort, Prothonotary, we find there is due him from the County the sum of One Hundred Eighty-eight and 2/100 dollars (\$188.22).

The account of W. E. Hurly, Sheriff, was carefully examined and found to be correct, and find there is due him from the County the sum of Two Thousand Two Hundred and Fifteen and 35/100 dollars (\$2,215.35).
