

Some very peculiar returns have been made. In Snow Shoe township and borough the registration was almost solidly Republican, while heretofore the Democratic vote was about two-thirds as large as the Republican vote. The present returns sure indicate a "nigger in the woodpile" somewhere, and it is possible that he will be canght on primary day, September 21st. The registration of Bellefonte shows an even 200 Republican majority. Changes in other parts of Centre county are not so noticeable.


