Sixty thousand auto fans thronged the big bowl, at Tipton, on Sunday, to see the exciting races on the Altoona speedway which had been postponed from Saturday owing to a hard rain storm just before the races were to have been called. Sunday observing citizens, of Altoona, made an effort to prohibit the holding of the races, on Sunday, but were unsuccessful. First, action was brought against the Speedway association charging violation of the State blue laws. Each one of the officials posted \$300 bail for a hearing, but went right ahead with arrangements for the race.

Application was then made to the district attorney of Blair county for an injunction to restrain the association from pulling off the races.
