THE BREAKING UP OF PARTIES. / 4 War Speech from Senator Douglas.

Slavery has been directly or indirectly the cause of breaking up all the political parties eause of breaking up all the political parties which have existed in the United States during the present generation. The old Whig party, formidable as it was for numerical strength, and splendid as it was in respect to the intel-lect of its leaders and the material of its rank and file, did not survive the administration of Mr. Fillmore. The Fugitive Slave Law and the other compromise measures of 18500 prehaps saved the Union; but they were the desth of the Whig party, for from that time its decline was swift and vertain. The American party, sprang up from the ashes of Whiggery, also died of the Slavery disease. The National American Convention, which met in Philadelphia in 1855, split upon the famous twelfth section which endorsed Slavery, and "Sam's" back was broken from that period. The Democratic party was the next great victim to, the African Jaggernaut. Democmay had stood a good deal, and it was prenarel to bear much before it would consent to be rent in train; but Lecomptenism and Buchannanism were more than any party that ever existed could bear and live, and the death throes of Democracy were plainly visible int Charleston and at Battimore in 1860. The iat Uharleston and at Battimore in 1860. The Slave power, fieding it could no longer control the Democratic party, threw that great organ-ization overboard, and Demogracy had no longer a national existance. This result was plainly forestadowed by the great apostle of Sceession half a century ago. Within a few days a letter, written 19 Commodore Charles Stewart, under date of the 4th inst., has been published, and in it "Old Ironsides" gives the details of a conversation which he had at published, and in it " Old Ironsides" gives the details of a conversation which he had at Washington with John C. Calhoun in 1812. Commodore Stewart says that, aNer discussing with Mr Calhoun the conflicting sentiments of the North and South respecting the war, he

remarked: "You in the South and Southwest are decidedly the aristocratic portion of this Union, you are so in holding persons in perpetuity in slavery; you are so in every domestic quality; so in every habit of your lives, living and actions: so in habits, customs, intercourses and manners. You neither work with your hands, head, nor with any machinery, but live and have your living, not in accordance with the will of your Greator, but by the sweat of slavery, and yet you assume all the attributes, protessions and advantages, of Democracy." Mr. Calboun replied:---"1 see you speak through the head of a young statesman and from the heart of a patriot, but you lose sight of the politician and the sectional policy of the people. I admit your conclusion in respect to us Southrens; that we are essentially aristocratic I cannot deny, but we can and do yield much to Democracy. This is our sectional policy; we are from necessity thrown upon and solemnly wedded to party, however it may occasionally clash with our feelings, for the conversation of our interests. It is through our affilimation with that party in the Middle and Western States, we control, under the Constitution, the governing of the United States, but when we cease thus to control this nation, through a disjointed Democracy or any material of stacle in that party which shall tend to throw us out of that rule and can'rol. we shall then resort to the discolution of the Union. The compromises in the Constioution, under the then circumstances, were sufficient for our fathers, but under the altered condition of our country from that period, leave to the South no resource but dissolution; for no amendments to the Constitution could be reach-

ed through a Convention of the people and three fourths rule." 


