

I had charge of 330 wounded-have three Surgeon with me. Fifty-six have died. I have got through

all the operations. If we are not relieved soon the mortality will be fearful. Men with amputated limbs can't live on bread and water, and after to-morrow morning I will not have even a crumb of the former Dr. Vaughn accompanied the wounded who were sent to Washington. I have heard nothing from him singe. I am very anxious to hear from home, also to see a paper and ascertain what is going on. I an going to send a man through to Fredericksburg in the norning and will give him this letter, which I trus you will receive. I have sent tan messengers and but one has returned. Trusting that you are all well and that I may soon be in a more comfortable situa


