

OBITUARY. MAJOR WILLIAN WATSON ANDERSON died near Harper's Ferry, Va., Jan. 16, 1865, in the 26th year of his age. He intered the United States service September 1861, with the rank of 1st Lieutenant, was promoted to a Captainey early in 1863, and to a Majority in 1864. The Mass a' young man of great innate nobleness of soul. In disposition he was amiable and demonstrative. He attracted many and repelled none. Strong men wept when they heard of his death, and the touching sceness which occurred at his funeral will not soon be forgotten. As a soldier he had few superiors. He was as brave as hatriotic. An officer remarked that it was Major Ander-on's pride and boast that he had never disobeyed an or-ter though he may have failed in its execution. Where why called he went, registriless of danger. Such was his worth that when there were many applications for the command at Harper's Ferry, it was assigned to him, though he had expected to return to his home in Teinerary on

tion. He had expected to return to his home in February on account of his father's ill health, but God called him, at an unexpected hour, to another world. The way of God is often in the sea, and His path in the great waters, and His footsteps are not known. But what we know not now we'shall know hereafter, and looking at this sad bereavement in the Hight of the next world, we shall say with thankfulness: "He hath done all things well"

Southern Pennsylvania Rail Road. Speaking of this road the "Chambersburg Repos

itory" says: We learn that the work is being pushed as rapidly

as possible, considering the great scarcity of labor and exorbitant prices of everything pertaining to the construction of Railroads. The apprehension of some of our people that this important work will be stopped when the connection with the Huntingdon and Broad Top Road is made, is, we are well assured, entirely groundless. That connection will first be made for obvious reasons, as it at once makes the part of the road already made, productive; but it is not contemplated by any one connected with the management to abandon the connection with the Cumberland Valley. There is some doubt as to just where the new road will intersect the railroad line of this Valley; but we hazard little in saying that it will be at this point, or south of it. It would now be impossible to complete the entire road in the time prescribed by the act of incorporation, and an extension will be asked for ; but the company will not seek to be relieved from completing the eastern line of the road. An effort is now being made to locate it in Maryland, and bring it from Cumberland 'to Hagerstown; but we hope to see it pass through our county. If located in Maryland, we should lose direct communication with the Broad Top coal fields, and received in exchange direct communication with the Cumberland Coal beds.
