IMPORTANT TO LANDLORDS .- The stamps required on landlord's and tenant's agreements are not "fifty cents" as formerly, but are materially changed by the last act of Congress as follows:

'Lease, agreement, memorandums or contract for the hire, use or rent of any land, tenement, or portion thereof, where the rent or rental value is three hundred dollars per annum, or less, fifty cents; where the rent or rental value exceeds the sum of three hundred dollars per annum for each additional latwo hundred dollars, or fractional part thereof in excess of three hundred dollars, fifty cents." All agreements, leases, &c., not stamped in conformity with said act are void.

HUNTINGDON AND BROAD TOP RAILROAD .- During the year 1864 the Bedford Railroad, with all its franchises, was purchased by and consolidated with the Huntingdon and Broad Top Railroad and Coal Company at a cost of \$70,000, whereby the line was extended from the Pennsylvania Railroad at Huntingdon to the town of Bedford. This movement, says the Philadelphia Gazette, derives importance from the incorporation of the Southern Pennsylvania Railroad Company, and the certainty that the line of that work will forthwith be put under contract and built from Bedford to Connellsville, and so the route from Huntingdon to Pittsburg, via Broad Top Bedford and Connellsville, may be run as a through line the moment that the new link shall have been completed. By this arrangement the western division of the Southern Pennsylvania Railroad will be rendered available and lucrative as soon as built, without waiting for the building of the eastern di-

This connection will largely enhance the value and importance of the Broad Top Railroad. At present its trade is limited by the difficulty of obtaining trans portation for its coal, to obviate which six hundred new eight-wheeled cars have been ordered by the Pennsylvania and Reeding Railroads for the Broad.
