Rye is held at \$1 10 for Pennsylvania, and \$1 05 for Western. Corn is quiet at previously quoted rates, with sales of 1,000 bushels old yellow at \$1 04 1/2, and 3,000 bushels new do. at \$1 06 1/2. Oats are unquiet at \$1 05 for 2,000 bushels. Pennsylvania at \$1 05 1/2, and Delaware at \$2. No sales were reported in barley or malt. Barley—Holders are asking \$2 50 per ton for No. 1, and \$2 40 for No. 2. Timothy may be quoted at \$1 15, and \$1 10 for No. 2. Whisky is quiet at 1 04 1/2 per gallon for wood and iron bound Western.
