PENSIONS TO OLD SOLDIERS—The Auditor-General, lately, transmitted to the State Treasurer full lists of old soldiers of the war of 1812 and their widows, of Pennsylvania, whose applications for pensions under the act of assembly of 1868, have been examined and adjudicated. In a few days these lists will be re-compiled and classified by the clerks in the treasury department, and transmitted to the various county treasurers, with the funds requisite to meet the demands of the heroic veterans and their widows, who will all be paid in their own county. Those who have not heretofore received pensions, either under the act of 1865 or under special acts, will be paid sixty dollars, including forty dollars gratuity and twenty dollars for one half year's annuity. Those who have not heretofore received pensions under the act of 1865, will only receive twenty dollars. The balance of the annuity for 1868, will be paid by the first day of January, 1909.
