THE COMING COUNTY STATEMENT.

The approaching session of the County Auditors to examine and report upon the Annual County Statement will be watched with much interest by the tax-payers of this County.

In the first place, "County Auditors are sworn, (or should be)," to perform the duties of their office with fidelity, and if they neglect or refuse to perform the duties enjoined upon them by law, they forfeit the sum of \$100.00, to be recovered by the County.

In addition, settling and adjusting the accounts of the Commissioners and Treasurer of the County they have the power to issue subpoenas to obtain the attendance of the officers whose accounts are required.

But in case of an erroneous audit, or collusion between the auditors and the officers whose accounts are to be examined, what remedy is there? The law-payer cannot appeal.
