In the Court of Common Pleas of Columbia County. John G. Press vs. Motion to strike off The County of Columbia.

1. Counties are not Municipal Corporations within the meaning of the 8th section of the 16th article of the Constitution nor of the Act of 18th June 1874, providing for appeals in certain cases.

2. The taking of private property for the purpose of highways under the constitutional law, is not by virtue of any privilege invested in the counties, but is an act of power on the part of the State, exercised through its judiciary.

3. No appeal lies to the Court of Common Pleas from assessments of damages caused by the laying out of public roads by proceedings in the Quarter Sessions.

OPINION BY ELLIOTT, P. J. In pursuance of an order issued out of the Court of Quarter Sessions of this county, the viewers to whom it was directed reported that they had viewed and laid out for public use a road from a point on a public road near George Ziegler's in Scott township to a point on Mt. Pleasant road in Bloomsburg—

that the road so laid passes over the improved lands of the plaintiff and that they had assessed his damages at the sum of one hundred and eighty dollars.

Within the time limited in, and in manner and form as provided by the Act of 13 June 1874, Pamph. Laws 288 an appeal was taken by the plaintiff and duly entered upon the record of the Court of Common Pleas.

On motion of Counsel for the County, a rule was granted to show cause why this appeal shall not be stricken off. The questions raised by this rule by consent of counsel were submitted to the Court without argument.

The Act of 1874 was passed for the purpose of carrying into effect the 8th section of the 16th article of the Constitution, and in its first section provides as follows: "In all cases of damages assessed against any municipal or other corporation or individual or individuals, invested with the privilege of taking private property for public use, for property taken, injured or destroyed by the construction or enlargement of their works, highways or improvements whether such assessments shall have been made by viewers or otherwise than upon a trial in Court, and an appeal is not provided for or regulated by existing laws, an appeal may be taken by either party to the Court of Common Pleas of the proper county within thirty days after the filing of a report thereof in Court pursuant to any general or special Act, and not afterwards."
