And that the officers may be personally indicited for neglect of duty. In this State the practice has uniformly been to proceed against the officers. The 7th section of the Act organizing the Town of Bloomsburg confers upon it all the powers of boroughs given by the several sec-tions of the Acts of 1834, 1851 and 1856 there.

The Act of 1834 makes it the duty of a burgess of a borough to cause to be opened all the streets, lanes or alleys, and for neglect or refusal so to do makes him liable to like penalties as incurred by supervisors of highways for similar effences. The Act of 1851 gives power to regulate the roads, streets, &c., and the beights, grades, widths, slopes and forms thereof and all needful let not Pennsylvania's soil hold a single one that may be marked forgotten! Eather let the constories of the Keystone State be strewn with flowers, till every veteran's tomb shall wear a mantle of beauty fit for such a shrine .
