BROOKS HIGH LICENSE LAW.

The Brooks High License Law is exercising the minds of the lawyers in every judicial district in the State, as it has become necessary to formulate and adopt a code of Rules for practice under it. All applications for license must be made and heard at a time to be fixed by a Rule of Court, and shall be for one year from a date fixed by Rule of Court.

Under old law license could be granted.

Under old law license could be granted at the first or second terms of Court in any year; and they expired in February or May as the case might be. This is no longer the case and to fix a time least inconvenient to parties, witnesses and Court, and at the same time to prevent losses by lapses of license or duplicates thereof, are matters of no little difficulty; and indeed in spite of the best consideration that can be given to the subject some losses are inevitable, which the court is powerless to remedy.

The law is imperfect in its details.

The law is imperfect in its details and in many respects very inefficiently drawn; and how much of the old legislation remains and how much is repealed will occasion great confusion in the practice of the law. There is no general repealing clause in the Act, and all pre-existing laws not supplied by it remain in force. There is no provision, for instance, about the transfer of a license granted under the previous laws, but the courts have been held to transfer license heretofore granted.

The Act is so drawn as to be not subject to any logical system of construction. It does not in any place require that the applicant shall have had, home accommodations, or stable room, and yet in the fifth section it requires the petitioner to set out that the place licensed is necessary for the accommodation of the public; and in the seventh section the court may refuse the license when such license is not necessary for the accommodation of the public; and the entertainment of strangers or travelers.
