WASHINGTON LETTER. From our Regular Correspondent. WASHINGTON, April 9th, 1888. Wanted, a leader in the House with sufficient nerve to discipline the members who have brought about the present protracted deadlock.

A large majority of the democratic members are opposed to the filibustering, but owing to the lack of a bold leader they sit around helplessly.

The deadlock began on last Wednesday, since when there have been only such recesses as were necessary for rest and refreshment.

On one night since the beginning of the deadlock a recess was not taken until 3 o'clock A. M. on another occasion when it was discovered that a quorum was not present.
