#### The Currency Issue.

C. A. Kleim's Drug Store.

Every effort ought to be made that is consistent with the safety of the business interests of the country to postpone the consideration of the currency question until after the revision of the tariff. Secretary Carlisle is convinced that the monetary conditions are daily becoming more satisfactory. Gold is coming in in adequate amounts and although there have been occasional renewals of the former demand for it there seems to have come an end to anything approaching lack of confidence in the Treasury.

The financial authorities at Washington, agreeing with Mr. Carlisle, are hopeful that the problem can be solved without drawing the question into the arena of immediate political debate. "The main issue on which Mr. Cleveland was elected was that of the tariff. That is the issue upon which there is most harmony among Democratic Congressman, and that is the one also in which the people of the country are most deeply concerned.

The money question is no longer confined to silver coinage. It now embraces the whole subject of our incongruous paper currency and involves the entire system of banking. More-over, it cannot be determined without a solution of the difficulties of those communities that have not proper banking facilities; in other words, that are not possessed of proper credit tokens for the transaction of their business.

The settlement of such problems will require very many months of deep study and thorough discussion. And in the mean time it would not be fair to the people who have demanded by an enormous majority that they shall be relieved from the burdens of tariff taxation imposed upon them by the McKinley act that the reform of that act should be postponed.

It is probable that the Administration will be able to take such steps as will convince the country and the financial world that a proper solution of the monetary question will be eventually reached, and that in the mean time American securities will remain safe investments. This being done, the attention of those who will be intrusted with the task of reforming the tariff will not be distracted, and the promises made by the Democracy can be fulfilled .- World.

Cleveland carpenters will be paid thirty cents an hour for a nine-hour day, begin-

Krouskoff millinery store at Savannah, Ga., with over \$100,000 Habilities. Mrs. General Handcock's funeral was held at New York Saturday and the body taken to St. Louis for burial.

With a \$30,000 cargo of seals, Captain Farquhar, of the steamer Newfoundland, has returned from Halifax, N. S.

Francis Kile, director of the poor of Montgomery county, died at North Wales. He was sheriff of the county in 1860.

Speculating with his congregation's money, Father Van Deven, of Butte, Mon., lost \$45,000 and has gone to Belgium.

The city election held in Danbury, Conn., resulted in a sweeping democratic victory. Charles S. Andrews was elected mayor.

Ercole Tamajo, duke of Caste Lucia, who married an American woman and lived in this country, died in New York.

Pedro Garcia, one of the so-called Garcia revolutionists, has been captured by United States troops near Fort Ringgold, Texas.

Charles A. Pillsbury, the miller of Min-neapolis, Minn., denies that he lost any-thing in the recent Chicago wheat deal. A. M. Stadler & Co., dealers in clothing at Cincinnati, O., have assigned. Assets estimated at \$40,000; liabilities probably \$50,000.

The Pelican saw mill, 1,000,000 feet of lumber, thirty cottages and a pile-driver were burned at New Orleans. Loss, \$100,-

An express car on the Atlantic and Pacific railroad was burned at Hancock, N. M., and \$100,000 in greenbacks destroyed. Of a similar amount in gold, a portion was melted.

The Akron, O., board of health has filed charges of incompetency against D S. Conklin, of Canton, president of the State board of health, in his management of smallpox.

The Pacific Coast Council of Trades and Labor Federations, with 40,000 members, has protested to President Cleveland against the appointment of O. W. Ed-wards as public printer.

At Cincinnati, O., Judge Sage, of the United States district court, has issued an order to Receiver Leland to act as commis-sioner for the sale of the Dayton Natural Gas Company's holdings. Edward Skimsucher, the Belgian who was shot in Paterson, N. J., on Sunday, by Victor de Wold, will probably die. Peter Vanderfleet, who was also shot, will probably recover. De Wold is in jail.

For forging a check that won \$12,000 worth of jewelry from Mexican jewelers, Robert Knox, a young American, was sen-

tenced to fifty-two months' imprisonment and \$800 fine and his wife to six months and \$225 fine. While showing how the electric lights N. J., opera house, John W. Crox, one of the proprietors, was terribly shocked, and his right thumb so badly burned that it will probably have to be amputated.

In the chancery court at Chattanoog Tenn., J. D. Roberts has been appoint receiver for the Lookout Iron Company on the application of the Harryman Manufacturing Company and the East Tennessee Land Company. The bill alleges that the iron company is in debt over \$185,000.

The East Jersey Water Company, which sold the city of Newark its \$8,000,000 water supply, has decided to appeal from the decision which allowed severae manufacturers, claims amounting to \$184,458.38 for depriving them of water by using the entire supply of the Pequannock river.

The British steamship Handel has arrived at Philadelphia with 2,500 tons of oranges and lemons, gathered at Messini, Palermo, Catania and Valencia, Italy and Spain. She met with heavy weather during the egtire run, and had her temporary hatches swept overboard by the heavy seas.

The failure of the Irwin Manufacturing The failure of the Irwin Manufacturing Company at Louisville, Ky., a few days ago was for \$75,000, with assets about half that amount. L. M. Pearce, one of the supposed indorsers for the firm, after inspecting some of the bank paper purporting to bear his signature, has pronounced it a forgery. C. H. Irwin, the head of the firm, is missing.

Charles Tieman, a Hoboken, N. J., butcher, received a verdict of \$1,000 in the county court against Druggist William Kamlah, whose clerk gave Tieman pure carbolic acid when he asked for a disinfecting wash for a cut finger. He applied the acid to the wound before he discovered the blunder and the finger had to be amputated in consequence. Tierman sued for putated in consequence. Tierman sued for \$5,000.

When John H. Webb, a clothes wringer peddler of No. 278 Grove street, Jersey City, failed to effect a sale to Mrs. Bes-singer, of No. 84 Pine street, he put his arm around her waist and tried to kiss her, but she applied a hot curling iron to his lips, blistering them severely and then called a policeman who dragged him to Police Justice Kimmerly's court, where he was fined \$20.

A big German carp was caught in the Schuylkill river by John DeHaven of Pettstown, a few days ago. When Mrs. DeHaven was preparing the fluny monster for the frying pan, she was astonished by finding in its stomach a pocketbook. This seemed to be in good condition, and when opened was found to centain a dime, two of a dress goods samples and a small photo young man with mustache and curly hair. young man with mustache and curly hair.

The three colored men, Fred Wood, Samuel Wobey and Percy Cato, who way-laid and attempted to kill Dapiel V. Bower, of Trenton, N. J., at the Pennsylvania railroad station at Bordentown, N. J., on the night of January 6, were taken to the Burlington county court to plead. Wood pleaded guilty, but the other two plead not guilty, in spite of the fact that all three had previously made confessions to Mayor Buscon of Berdentons.
