compensation shall be made; to enable tax collectors to collect taxes for the payment of which they have become personally liable without having collected the same; to enable boroughs not divided into wards for school purposes, to establish public high schools; extending the limits of residence and power of notaries public; extending the limitations of actions to a right to mine iron ore in lands where the same has not been exercised for a period of twenty one years.

The bill to prevent the pollution of inland waters and sources of domestic water supply came up as a special order on final passage at noon. Objection was made that the effect of the bill would be to place the sewage systems of every city, borough and town in the Commonwealth in the absolute control of the State Board of Health. The bill authorizing cities to purchase bridges already erected, or to erect and maintain bridges over streams and rivers which may separate portions of such cities, and providing for the condemnation of such land as may be necessary for piers, abutments, fills, slopes and approaches thereto, was amended on third reading so as to include boroughs.

At the afternoon session Mr. Bliss, of Delaware, introduced a bill appropriating \$50,000 to enable the Governor to acquire and equip a State quarantine station for the port of Philadel-


