monwealth, where said office exists to be concerned or personally interested in any con-tract for furnishing supplies for the main-tenance of the poor, or for the construction or improvement of property under their con-trol." The same law will apply to part of or-der No. 40 amounting to \$15.50 for carpenter work by one of the Directors on the buildings of the Poor District. Although the Poor District received the benefit of the amt. of these orders, yet the transactions were illegal and the Directors who received the money should pay it back to the treasurer of the dis-trict. triet. Orders No. 33 and 58, amounting to \$88 were given to pay for the services of two stewards during part of the month of March last. The Act of Assembly incorporating Bloom Poor District provides for the appointment of only one steward. It would therefore be illegal to pay for the service of two at the same time. The Directors who appointed and paid for the services of these two stewards should pay in-to the treasury of the poor district \$18, being the amount in excess of the regular salary of the steward of that year. The amount in excess of the regular salary of the steward of that year. Order No. 106, for \$10 to J. A. Howard for board and care of R. S. Miller up to Sept. 13th, 1985, was given without authority of law and should be paid to the Poor District by the Di-rectors, who authorized the payment. The order, shows that it was not drawn for the re-lifer of R. S. Miller but to pay bills which had been contracted previous to the time the or-der was given. The Supreme Court has de-cided that the overseers of the poor are strictly limited by the various Acts of Assembly re-lating to the maintenance of the poor and ex-cept in rare and special cases they carnot step beyond the letter of these acts. "This is allowed in special cases that." This is allowed in special cases they carnot to find Bioon Poor District. The actual cost of the coal detivered at Biomsburg was \$2.75 a ton, amounting to \$32.56 but the orders were made up of this amount, and of \$13.61 for ex-penses during two trips to Kington to pur-chase the coal.
