
# LOCATED AT LAST.

Monart's Skull Now Placed in the Hyrtl Orphan Asylum at Moedling, in Austria.

Owing to an extraordinary story which was recently circulated to the effect that Mozart's skull had been stolen from a museum in Vienna, the skull itself has now been found, and its history, which is an astounding one. has been traced and authenticated. Mozart's skull was never in the Mo-

tart museum in Vienna, from which it was alleged to have been stolen. It has now been placed in the Hyrtl orphan asylum at Moedling, in Austria.

It appears from the facts which have now been discovered that Mozart's

body was hurriedly interred along with the bodies of numerous victims of an epidemic. He died at the age of 34 and was buried on a stormy night in 1701, along with other victims of the disease, in St. Mark's cemetery, in Vienna.

Owing to the panie prevailing because of the epidemic there were no obsequies. The exact resting place of Mozart's body was known only to a grave digger called Joseph Rothmayer. Rothmayer was a skilled musician and a great admirer of Mozart, and in order to prevent the body from being stolen he wrapped long wires around the coffin.

Some time afterward Rothmayer, animated by musical enthusiasm, surreptitiously opened the grave and stole the skull. He kept it as a sacred relie until his death, when it became the property of one Radschopf, his succes-

Both these men maintained the greatest secrecy about their ghastly treasure. Joseph Hyrtl, brother of the celebrated anthropologist, became the next owner of the skull. Hyrtl was a musician of renown and an ardent admirer of Mozart, and Radschopf gave him the skull as a mark of esteem, one of the most extraordinary presents ever given by one person to another. On his deathbed only did Hyrtl reveal the secret. He then told his brother Joseph. The latter had the cranium carefully prepared and placed on a velvet cushion under a glass cover. With his own hand Joseph Hyrti inscribed the following words on the

temporal bone: "Wolfgang Amadeus Mozart

# Orangeville Borongh Ordinanco-No. 20

IN ORDINANCE AUTHORIZING AND EM POWERING W. R. CHAPIN AND CHARLES J. ROGERS AND T. W. HAINES OR THEIR GRANTERS OR ASSIGNS, TO CONSTRUCT MAINTAIN, AND OFERATE A SYSTEM OF WATER WORKS IN THE BOROUGH

OF ORANGEVILLE, FOR THE PURPOSE OF SUPPLYING WATER TO FIRMS, COR-PORATIONS, INDIVIDUALS AND CITI-ZENS THEREOF. Be it ordained and enacted by the Borough Council of the Borough of Orangeville and it is

hereby ordained and enacted by authority of the same

Section 1. That W. R. Chapin and Charles J Rogers and T. W. Hames or their grantees or assigns, be and are hereby authorized and empowered to construct, maintain and operate a system of water works in the Borough of Orangeville, to supply water to firms, corpora tions, individuals and citizens thereof, and for that purpose to lay and maintain the necessary pipes, joints, connections, etc., under the several Streets, Avenuez, lanes and alleys, of the said Borough of Orangeville; subject to the onditions and restrictions hereinafter con tained. viz:

Section 2. That said work shall be don under the supervision of the proper Borough authorities, and the services of the Borough Engineer when called apon by Council in this behalf shall be paid by the said W. R. Chapin and Charles J. Rogers and T. W. Haines or their grantees or assigns.

Section 3. That the said pipes, joints, conections, etc., shall not be laid or constructed so as to obstruct, impede or interfere with the free flow or passage of water, in, through, over, or upon any gutter, drain, sewer, culvert, pipe or water course; nor so as to interfere with on obstruct the convenient use of the streets avenues, lanes and alleys of the said Borough nor so as to interfere with or damage private property, or of any corporation in said Borough Work to be begun by said grantees within six months and the said water works and plant to be in full operation within one year from the date of the passing of this Ordinance or the franchises nereby granted are forfelted.

Section 4. That the said W. R. Chapin and Charles J Rogers and T. W. Haines or their grantees or assigns, shall repair and make good all damage or injury to the streets, avenues lanes and alleys of the sold Borough, and side walks thereof, and shade trees thereupon, ased by them for the purposes aforesaid.

Section 5. That the said W. R. Chapin and Charles J. Rogers and T. W. Haines or their grantees or assigns, shall so lay and maintain their pipes, joints, connections, etc., so as not to interfere with the pipes, joints, connections etc., of the citizens and the municipality, now having pipes, joints, connections, etc., unde the several streets, lanes and alleys of the said Borough

Section 6. That the said W. R. Chapin and Charles J. Rogers and T. W. Haines or their grantees or assigns, will indemnify and alway save and keep harmless the said Borough of Orangeville, of and from all act ons and manner of actions for damages arising from the laving, maintaining of pipes, joints, connections, etc., under the several streets, avenues, lanes and alleys of the said Borough, and fo that purpose will give the indemnity as hereinafter specified.

Section 7 That the said W. R. Chapin and Charles J. Rogers and T. W. Haines or their grantees or assigns, shall pay the cost of drawing printing, publication and posting of this Ordinance; and that before the provisions of this Ordinance shall become operative and valid and enure to the benefit of the said W. R. Chapin and Charles J Rogers and T. W. Haines or their grantees or assigns, they, the said W. R. Chapin and Charles J. Rogers and T. Haines or their grantees or assigns, shall first file with the Council their written accentance of this Ordinance, and enter into a Bond with sureties to be approved by the Chief Burgess to the said Borough in the penal sum of five thousand dollars, (\$5000.00); conditioned upon the faithful performance of the conditions of Sheriff. Section 8. The said W. R. Chapin, Charles J. Rogers and T. W Haines, or their grantees or assigns, hereby agree to furnish water for the use of the Borough for an annual rental not ex-Corner Main and Centre Stre t ceeding seventeen dollars for each fire plug, As many of said plugs as shall be desired shall be placed in said Borough at the own prope cost and charge of the receivers of this fran chise, to wit: W. R. Chapin, Charles J. Roger and T. W. Haines, and when once placed shall become absolutely the property of said Bor ough. Passed December 2nd, 1901.




