

When we remember that this Act is one affect-When we remember that this Act is one affect-ing public interests and relating to public officers, and that it is, therefore, mandatory upon such public officers, we can have no doubt as to the legal effect thereof. The old laws provided one method of ascertaining the occupation tax, while the new Act provides a different one. Both can-not stand, and for this reason the later Act must be held to operate as a repeal of the former pro-vision

With these observations, you are advised that, nder the laws, as modified by the Act of July 2, 1897, school boards have authority 1. To assess and levy taxes for school purposes

To assess an occupation or per capita tax of one dollar upon each and every male inhabitant of the age of twenty-one years and upwards. 
