

Some of these hard hearted legisla tors are not paying the attention they should to the pleadings of the corpo rations. The Pullman com-pany also needs the money although a financial statement of the company's affairs showing millions of dollars profits over and above the dividend requirements would not indicate porerty. Mr. McCullagh of Allegheny, who introduced the bill, has gathered 37 quite a bit of data in support of it. The capitol extension bill has been 93 59 75 sent back to committee in order to make some changes in it to conform with the ideas of those who have op-27 posed the purchase of the land to be added to the capitol park. It is proave ac-om-the ton ore-ne. ry, posed to change it in such a way as to prevent speculation on the part of real estate men and others who would endeavor to make money at the gov ernment's expense. It is proposed to spend about \$1,800,000, which is a little more than one-half of the amount specified in a bill introduced last ses-1.100 sion. There is not much prospect of the measure going through, however, as the general trend of feeling here is for economy and reform.
