Joe Pagano Pays The Penalty

clasping in his hands a cross and crucifix, and stood under the scaffold await ing the final summons that should send him to eternity. Ex-Sheriff C. S. King, of Port Allegany, who has assisted at many executions in the past twenty-five years, adjusted the rope, when the Priests and prisoner repeated a series of prayers. At this juncture Pagano asked for Santo Legato, (a shoemaker employed in the A. F. Vogt's store), with whom he used to board. Sheriff Norris sent for his friend to whom he said: "Tell mother I have done wrong, but please forgive me. Tell sisters to be good girls." These were the only words spoken under the gallows. Before leaving his cell he said to Father Downey, who had been almost daily his visitor for several weeks: "I was a bad man while working in powder and might have been killed and lost. Now I am prepared to go and am saved," at the same time shaking hands with all the prisoners and bidding them good bye. As the black hood was drawn over the head of Pagano, who was kissing the cross and crucifix, Sheriff King signalled to Sheriff Norris "all right" when Sheriff Norris severed the rope, in an instant, swinging Pagano into the air as the heavy weighted box fell a distance of three eet. This was exactly at 10:11. The victim never knew what struck him. his neck being broken; not even a quiver or movement of muscles. Father Catelanno, of Shawmut, an Italian Priest, continued to offer prayer until Drs. H. S. Falk and H. W. Bush, of town, and Drs. McGrainer, of Port Allegany, and Ostrander, of Smethport, pronounced him dead, his pulse ceasing to beat at 10:24, it being just thirteen minutes after the trap fell. At 10:28 his body was cut down and given in charge of Undertaker Egan to prepare for burial, his friends having arranged to give his remains a christian burial in the Catholic cemetery, the funeral taking place from B. Egan's undertaking rooms yesterday morning, at eight o'clock, Rev. Thos. B. Downey officiating.

The Sheriff, District Attorney and Sheriff's Jury repaired to the court house when the final affidavits were prepared and signed, as required by the law. Sheriff Norris thaked the jury for their assistance and expressed a wish that neither would again be called upon to act in similar manner.

NOTES AND INCIDENTS. The tax-payers of Cameron county have, or will have to pay all the expenses from start to finish, which will amount to about \$2,500. This in addition to the trial and execution of Odell will foot up to about \$6,000.

The execution attracted a very large attendance, many coming from ad-joining counties. The Sheriff displayed guarded discretion and refused to admit any Italians, except Santo Legato. In fact no Italians came near the court house grounds, having made their visits before the execution.

Very many Sheriffs and other county officials attended the execution on Tuesday.

It was just seven months to the day when John Kibe was buried that Joe Pagano paid the penalty.

About seventy persons witnessed the execution, including the deputy sheriffs.

Joe Pagano, the victim of his crime, leaves a mother and two sisters in Italy, to whom he sent \$20.00 every two months. His mother, who had been notified of the date of execution, bed her boy might be saved from the gallows. She was written to and possibly received a letter on Monday apprising her of the execution on Tues-




WILLIAM ALEXIS STONE-1899-1903.

William Alexis Stone was born on a Tioga county farm in 1846. When the civil war broke out he was too young to enlist; but, with several other boys, he ran away from home, and because of his unusual size he was permitted to enlist. His father demanded and obtained his discharge, but a few months later he became a private in Company A, One Hundred and Eighty-seventh Pennsylvania volunteers. In 1865 he was commissioned as second lieutenant. He was from 1871 to 1875 lieutenant colonel and assistant adjutant general of the Thirteenth division of the national guard. He was admitted to the bar in 1870 at Wellsboro. He took up his residence in Pittsburg in 1877 and from 1880 to 1886 was United States district attorney for the western district of Pennsylvania. He represented the Twenty-ninth district in congress from 1891 to 1898. He was elected governor in 1898 after a hard fought battle



DANIEL HARTMAN HASTINGS-1895-1899.

Daniel Hartman Hastings was a schoolieacher before he was fifteen years of age and when still quite young became principal of the academy at Bellefonte and afterward was superintendent of schools. For some time he was editor of the Bellefonte Republican. He was admitted to the bar in 1875 and editor of the Bellefonte Republican. He was admitted to the bar in 1875 and for thirteen years was in active practice. Becoming interested in 1888 in the coal mining business, he retired from his law practice. When General Beaver became governor he appointed Mr. Hastings adjutant general. General Hastings' services in behalf of the Johnstown flood sufferers will long be remembered. He made the speech nominating General Beaver for governor in 1886 and two years afterward made the speech nominating John Sherman for the presidency. Again in 1896 he made a speech nominating Matthew Stanley Quay for the presidency. General Hastings was defeated for the Republican nomination for governor in 1890, but in 1894 was nominated by a unanimous yote and elected. nated by a unanimous vote and elected.



EDWIN SYDNEY STUART-1907.

Edwin Sydney Stuart, the present chief executive of Pennsylvania, was born in Philadelphia Dec. 28, 1853, of Scotch-Irish parentage. At the age of fourteen he obtained a position as office boy in Leary's bookstore, Philadelphia. Governor Stuart always took a lively interest in politics. He se two terms as president of the Republican State league, in 1888 and 1889. to the highest vote on the ticket. Four years afterward he was a delegate to the national convention which nominated Benjamin Harrison. In 1891 he was elected mayor of Philadelphia by the largest majority ever given mayoralty candidate. He was elected governor in November, 1906.
