Dear Freeman-In your last issue I noted the arrest of an alleged horse thief by Major Ryckman, and although circumstances seemed to indicate that the young man had came by the horse surreptitiously, his reticence in regard to his name, or anything pertaining to himself, and no possible clue fixing his identity in the supposed stealing of the animal being obtainable, it was deter-mined, on Monday last, to discharge him, mined, on Monday last, to discharge him, but when just about permitting him to take his departure a constable from Canonsburg, Pa., made his appearance, and at once identified him as a young fellow named Rodebaugh, who, it was supposed, had stolen the horse, and recognized the animal as the property of a citizen of that locality. After satisfying the Burgess that he was all that he represented himself to be, he was permitted to take the prisoner with him, to be lodged in jail at the above place until he could be tried. The prisoner was "hobbled," but at Homewood Station, near Pittsburgh, he succeeded in making his escape through a car window, just as the train was starting, and the strange part of the story is, that ala car window, just as the train was starting, and the strange part of the story is, that although the constable jumped off and caught him, he alleges the boy's grip was stronger than his, and so he escaped. There is something peculiar in the idea of a hobbled boy escaping from a stout, active man, and I could not help remarking the singularity of the affair at the time the constable was narrating it. To my mind it seems clear that the supposed officer was a confederate, and after permitting his prisoner to escape he returned to get the horse. The police had, however, "smelled the mice," and refused to deliver up the animal until the owner would make his appearance.

Now, Mr. Editor, I am well aware that the exercise of a little more modesty in speaking of one's own particular locality would be becoming in your humble correspondent; nevertheless, duty seems to impel me to hold up this dear little place to the admiring gaze of all lovers of beauty, of fairness—in fact, of general amiableness. But enough of this, and now for

Observations in Old Westmoreland.

The crops of wheat, rye and grass are said never to have looked better in this county at this time of the year. Fruit is likely to be a very slim crop here, especially apples and pears. It was killed in the blossom by the cold rains. I was in some instances as-tonished at the highly cultivated appearance of many of the farms, especially in the neigh-borhood of towns, and particularly in the vicinity of Latrobe and New Derry. You may be surprised when I tell you that some of these farmers have a greater and more tastefully selected variety of ornamental trees and shrubbery than there are at Cresson, not to of fruit trees. Portable steam saw mills are rapidly converting the larger growth of the remaining natural groves of timber into fenc-ing boards and other lumber, and fences well built of locust posts and white oak boards, are rapidly shoving the old rail back out of view from the more public thoroughfares.

Blackberries don't appear to be of sufficient value to induce the farmers in this

county to give them room to grow, even in the fence corners, and you may ride many miles in different directions without seeing a handful of anything in the briar or weed line.

But I must not forget to notice the general neatness, taste and substantiality of the buildings. Indeed, some of these farmers' residences approach a palace-like appearance.

Of course there will be too much of this for your many agence but I cannot close un-

of course there will be too much of this for your spare space, but I cannot close until I have told you that I saw and took the dimensions of the log house built on the north side of the Loyalhanna creek by Maj. Cochran, who accompanied Gen. Forbes on his expeditions against the Indians in 1758, I believe, and whose descendants (the Cochrans) still reside in that neighborhood. This habitation of that daring old pioneer has peculiar interest for the antiquarian. It is culiar interest for the antiquarian. It is built of white oak logs, slightly hewn, and is 24 by 22 feet. The fire-place is 12 ft. wide, including the thickness of the jambs. The mantelpiece is of white oak, and where it rests on the jambs is 80 inches square. The doors are placed opposite to each other, and I was told that the old Major had a particular object in so placing them, as it enabled him to haul in large sticks of wood, his him to haul in large sticks of wood, his horse entering by one door and passing out at the other. The gables are closed by clapboards, nailed on, the same that were first put on. The port-holes through which they used to shoot at the Indians are now closed. The entire building is in a tolerable state of preservation, and may stand another half century. This venerable building has been occupied as a dwelling until a year or so ago.
