THE RESULT IN CAMBRIA .- Amid the general defeat which seeths to have overwhelmed the Democracy in Tuesday's election, it is gratifying to know that Cambria county has in the main sustained her fair name, and given a Democratic majority on the State and the greater portion of the county ticket nearly up to her average 'majorities. It is also a source of great gratification to know that our candidate for District Attorney has been elected, notwithstanding a renegade Democrat was placed on the Radical ticket and many otherwise consistent Democrats struck hands with our political enemies in the effort to defeat Mr. Tierney. What his majority will be it is now impossible to determine, but while it will be small, probably not more than one or two hundred, it is concoded by all parties that he has been elected.

We give the vote, from such districts as have thus far been reported, on Auditor General, Congress, Assembly and District Attorney, the tabular statement thereof, as given below, having been kindly prepared for us by Wm. H. Sechler, Esq. :

Another grand rally" will be held on the Public Square to-night, and still another in Cambria city, which is to be conducted, I am told, by Messrs, D. J. Morrell and James Morley. two Radicals of this place who are now be fore the people for their suffrages.

The Democratic mass meeting here on Saturday was a grand success. The meeting in the afternoon was well attended, while in the evening there was undoubtedly the largest turn out ever witnessed in Johnstown. Gen. Richard Coulter, of Westmoreland county, entertained the afternoon meeting with a powerful address, after which our talented ownsman, Hon. C. L. Pershing, delivered a forcible speech in his usually able and logical style. In the evening Gen, Coulter again spoke more at length, and Wm. H. Sylvis, Esq., President of the National Labor League, followed in a lengthy and convincing address


