The arrangements for the Fair are being advanced on the most liberal scale. The grounds of the Society are large and convenient of access, and money has been liberally expended in putting them in complete order. They embrace a good halfmile Trotting Course, which has been in use for several years by the Johnstown Park Association, and is in good condition. Sheds for the shelter of animals and commod ons buildings for the accommodation of exhibitors and visitors are being crected, at a cost of nearly \$5,000. The Society offers a Premium List aggregating about \$3,000, copies of which, in pamphlet form, giving full details, may be had on application to any of the officers of the Society. The following is a summary of the Premiums offered for stock.

> For Horses..... \$985 00 or Cattle. 458.00 For Sheep 64 00 48 00 For Poultry..... 82 00

Other premiums in proportion for farm products, seeds, vegetables, farm implements. fruits, flowers, ladies' handiwork, and miscellaneons articles. All premiums owarded will be paid before leaving the Fair Grounds on the last day of the fair. Arrangements have been made with the Pennsylvania Railroad Company by which all animals and articles intended for the Fair, on which freight had been paid to Johnstown, will be returned by the R. R. Co. free of charge. Excursion tickets will also be issued to Johnstown from Tyrone, east, and Greensburg, west, and all intermediate stations, on Monday, Tuesday, Wednesday, Thursday, and Friday, good for return on Saturday. There will also be two trains each day of the Fair, to Ebensburg and return, stopping at all intermediate stations.
