

He was engaged in upon this island, is quite an extensive one, there being at that time, by rough estimate, between fifteen hundred and two thousand barrels of herring in the packing shed. They also catch a great number of shad, mullets, perch and hickory shad, yet none are packed To the right the town of Havre de Grace could be distinctly seen. Further down the Bay the lighthouse loomed up in the gathermerous gill-nets floating man the water. A SAN DEATH.-Killed of the Steel Works which resulted in his death about twenty wheeling some scrap in a wheelbarrow to one of the converters, and in cottinning bac wards he forgot that the "hoist," as it i called, had been lowered, and consequently he stepped over the trap, falling a distance of about thirty-four feet, striking his head against the springs that are attached to the elevator. The rear portion of his skull was fractured and one of the veins leading tothe brain severed. He was able to speak after being picked up, but only in a rambling kind of a way, and shortly after being removed to his boarding house on Iron street, Millville borough, he relapsed into insensibility. Doctors Lowman and Walters were promptly summoned, but they inmediately saw that medical aid would not avail. His injuries were of such a nature that no human skill could save him, and no attempt was therefore made to do anything for him. Shortly after being brought to his boarding house he expired. The deceased resided in Martinsburg, Blair county, and only commenced work at the Steel Works. on Thursday of last week.
