This proceeding is unparalleled in the history of the state, as it will be the first instance in which the offense of treason against the commonwealth has been charged and tried in the courts. caused by the hard hitting hail. Half a dozen people were seriously in jured by the runaways, but none fatally

hurt. The sharp lightning that snapped almost incessantly during the half hour's hail storm not only added to the general terror but fatally injured Charles Hoppe, a grocery clerk, and killed the horse he was riding. Telegraph wires suffered severely, not less than 200 of them being burnt out, the hail breaking them down and bringing them in contact with the electric light wires.


