The claims date back to 1871, when in the coarse of a revolution in Venezuela three of the vessels of the American corporation were seized by the Venezuelans on either side in the controversy. and much damaged by being used in war. The ships were finally recovered. one through the good office of the commander of a British warship and the other two by the commander of the United States steamship Shawmut. The claim also included items based on the refusal of the victorious revolutionary government to allow the company to exercise the franchise it held to navigate Venezuelan waters, and also items for the imprisonment of the masters of the seized vessels.

# IRONWORKERS MAY STRIKE.

A Conference Saturday Decides It For the Shenango and Mahoning Valleys.

PITTSBURG, March 27 - The conference on the proposition of the Ohio Valley manufacturers to pay only \$3.50 per ton for puddling, and a general reduction of 15 per cent in the finishing departments will be held on Saturday President Garland of the Amalgamated association declined to express an opinion as to the result of the meeting.

The lodges of the association have voted against the acceptance of the sweeping reductions, and it is probable the cut will be refused. Unless the manufacturers withdraw the offer a strike is likely to be declared in the Shenango and Mahoning valleys, and fully 10,000 men will be idle.

#### A Brave Ex-Warden Dead.

MONTREAL, March 27 .- Ex Warden Laviolette of St. Vincent De Paul peni tentiary has died here. It was he who subdued the great convict revolt eight years ago at the penitentiary. At the time of the revolt he was captured by the convicts in the yard and used as a shield while they made an attack on the wall. The guard naturally feared to fire, but Laviolette ordered them to do their duty, with the result that he received four bullets from the guns of his own guards in his body, while severa convicts were killed and the revolt was squelched As a reward, the Dominion government retired him on full salary
