R. had always held out to the townships officials that they would do something toward a new road, but a few weeks ago notified counsel that nothing would be done by them, as they did not hold themselves legally liable. Papers in mandamus proceedings against the P. R.

R. are now in preparation and will be presented in court in Philadelyhia next week for a suit compelling the railroad to make a new highway in place of the one taken by them. These proceedings will settle the question of the liability of the Pennsylvania railroad in the matter.


