A TERRIBLE EXPLOSION IN AN ENGINE ROOM AT SPRING MILLS MARKET. SEVEN MEN WERE KILLED AND SEVERAL INJURED.

London, January 21.—The press association states it is reported that an explosion has occurred in the Lyceum colliery, near New Castle. The number of persons killed is variously stated at from forty to one hundred. Later accounts state that from seventy to ninety persons were killed by the explosion.

London, January 21.—The latest accounts from the scene of the colliery explosion in the number of persons in the pit when the explosion occurred at 10.15 p.m. who were rescued are being rapidly. The work at the mouth of the pit is most heartrending.

NEGRO REVOLT. Several Planters Murdered and their Dwellings Burned.

Panama, January 10.—A revolt of negroes has occurred in the department of Chiriqui, and a horrible butchery has been committed. It is reported that more than a hundred negroes have been killed, and their dwellings burned.
