LAW FOR FARMERS—CATTLE IN THE HIGHWAY.

Mr. H. A. Halse, LL. B., of Detroit, gives a resume of the laws on the above subject, in the American Agriculturist for June, from which we extract the following:

It is the general doctrine of the law in this country that the land in the highway belongs to the general land, and the right to use it is common to all. With a few exceptions the American farmer extends to the middle of the road, and the right to use it is common to all.
