Ancient Marine Harness Fished Up in the Search for Valuables.

CHATHAM, Mass., May 26 .- The schooner Luther Eldridge, Captain D. W. Nickerson, and the Emulator, Captain B. A. Kendrick, has arrived here from an anchordragging cruise outside Chatham Beach. W. D. 



THE POPE DEFIED.

Seldom has any religious authority is. sued an order which has met with such indignant protest as the recent Papal rescript against the "Plan of Campaign" in Ireland. Although Roman Catholic prelates have explained it as relating only to matters of morals, and not at all to politics, it has been universally recognized as a political blow at Irish agitation, and a powerful blow in favor of the British Government. Forty Irish members of Parliament have voiced the sentiment of the Roman Catholic people of Ireland in a vigorous paper, which declares in detail that the allegations on which the Pope has based his decisions are false and unfounded, that the silence of the Pope in regard to the wrongs committed by the Government is deplorable, and finally that "while unreservedly ac knowledge the spiritual jurisdiction of the Holy See, we, as guardians of those civil liberties which our Catholic forefathers resolutely defended, feel bound to solemnly reassert that Irish Catholics can recognize no right of the Holy See to interfere with the Irish people in the management of their political affairs."

Thus far not a note is heard from any quarter indicating that this is not the sentiment of all the Irish Catholics. It therefore appears that the Papal interference has been utterly without effect to modify the situation.
