If anything should require it, however, I will not hesitate to avail myself of your very friendly offer. I thought I had nearly everything settled in my own mind that required attention before I reached Washington. I said to a friend today that if all seven of the cabinet officers could have been found in Alaska it would have promoted harmony in the party in the states.
