. A Gathering of 50,000 Veterans in Boston.

HONORS TO PRESIDENT HARRISON.

Escorted by Governor Brackett from the Cruiser Baltimore to the Vendome-The Vice President and Gen. Sherman Arrive from Bar Harbor-How the Veterans Are Accommodated-The Parade.

Boston, Aug. 12.—A great army has taken Boston. It is the same army that saved the Union. Fifty thousand veterans have camped inside the city limits. The advance guard marched in Saturday. At its head was Gen. Russell A. Alger, commander-in-chief of the Grand



MECHANICS' INSTITUTE. [Where 15,000 veterans are quartered.] Army of the Republic. He took up headquarters at the Hotel Vendome. The last of the rear guard came last night.

The Baltimore Arrives.

As the Baltimore, flying the president's flag and carrying the president, Secretaries Rusk and Noble and Private Secretary Halford, entered Boston harbor yesterday afternoon, she was met by the other vessels of the fleet, the Atlanta, Kearsarge, Petrel, Yorktown, Dolphin and the torpedo boat Cushing, all save the Kearsarge and Cushing firing salutes. The revenue cutter Gallatin, with Governor Brackett and Mrs. McKee on board, escerted her to her anchorage. Mayor Hart and other members of the city government also went down the harbor in the J. Putnam Bradlee to welcome the chief executive, while Mrs. Noble and other ladies were on board the Vigilant.

Landing of the President.

President Harrison landed at about 5:40 p. m. amid the thunder of cannon at Trow's wharf, and was escorted to the Hotel Vendome by the First battalion. The sidewalks and windows along the line of march, which was nearly two miles long, were packed with en-thusiastic multitudes who greeted the

president with hand clapping and cheers.
The president rode with Governor Brackett in a carriage drawn by four dark bays. He carried his hat in his hand and bowed right and left at the greetings of the throngs. Behind rode Secretaries Rusk and Noble, and in the third carriage were Private Secretary Halford and members of Governor Brackett's staff.

Banquet at the Vendome.

A few minutes having been allowed the visitors to remove the marks of travel the party proceeded to the state dining hali, where two long tables were arranged lengthwise of the room, with a third one across the upper end of the occupied the place of honor and the state's guest, the president, at his right, with Secretary Proctor on his left.

Also seated at the table were Secre tary Noble, Secretary Rusk, Governor Abbett, of New Jersey, and Lieutenant Governor Hale, of Massachusetts.

Brackett Breaks the Silence. The company sat down shortly before 7 o'clock, and it was past 8 when Governor Brackett broke the almost painful stillness that had prevailed throughout the entire feast with the announcement that carriages were waiting. This was the only audible speech that was made during the entire banquet, entire ab-sence of speech making being one of the conditions upon which the president ac cepted the invitation to a state banquet

The party, under the escort of the governor, were then driven to the Parker house, where they attended a reception given by the E. T. Kinsley post, of Boston, to Laylayette Post 149, of New York.

The Parade.

The parade, 50,000 strong, is now marching down Commonwealth avenue The right of line is held by Illinois, Wisconsin and Pennsylvania posts, followed in regular order by veterans from Ohio, New York, Connecticut, New Jersey, Maine, California, Rhode Island, New Hampshire, Vermont, District of Columbia, Virginia, Maryland, Nebraska, Michigan, Iowa, Indiana, Colorado, Wyoming, Kansas, Delaware, Minne-sota, Missouri, Oregon, Kentucky, West Virginia.
