ON AMERICAN SOIL.

Messrs. O'Brien and Dillon Land in New York.

GREETED BY GOVERNOR AND MAYOR

The Fugitives Receive a Cordial Reception from Irish Societies. Mr. O'Brien Gives the Details of Their Escape from Ireland-Programme of the Visitors.

New York, Nov. 3.—Mr. William O'Brien, M. P., and his wife; Mr. John Dillon, M. P.; Dennis Sullivan, M. P., and his wife, and Timothy Harrington arrived here yesterday on the steamer La Champagne. A reception committee representing the United Irish societies of New York, accompanied by several hundred members of the National League and the various Irish societies. met the steamer. Upon the arrival of the steamer at her dock a reception was held on her deck, and at 11:30 the vis-itors were driven to the Hoffman house.

The party had scarcely reached the hotel when Governor Hill called upon them. The governor warmly welcomed them to the city and state and expressed his hearty sympathy with the cause they represented and signed his name to the address of welcome that had been prepared by the Irish societies. Mayor Grant also called and expressed senti-ments similar to those of the governor and also appended his name to the ad-dress of welcome

Story of the Escape.

To the representatives of the press Mr. O Brien related the deta. s of his escape from Ireland as follows: "We delayed our trip as long as there was any chance of our being able to visit America in the interval between the sentence and the appeal. We saw that the government was deliberately eating away that interval, and as soon as that became evident we came away. The plan was simplicity itself. We went out of the front door of a conspicuous house in Dublin without any disguise at all. We drove in a friend's carriage to Dalkoy, supped at the house of Mr. Healy, and that night at midnight we were rowed aboard the yacht which set sail in a gale from Kingstown at once.

"While we were being provisioned just before the start, the coast guard came alongside and questioned Capt.

Murphy. Sheriff Clancy, of Dublin, was with us. We escaped detection and sailed for the Welsh coast, where we lay three days becalmed within a pistol shot of the shore, and in full view of the coast guards. Then we were becalmed three days more right in the course of shipping in the channel, and if half of the scrutiny had been given to us that was exercised in search ing outbound vessels we would have been detected sure. We reached the French coast on the evening of the seventh day, and went to Paris.'

After remaining here until after the election, the visitors will hold meeting in Philadelphia, Boston, Newark and Jersey City. They will then hold a series of meetings here and afterward divide into two or three parties and make a tour of the country.

Mr. O'Brien last night gave to the press a circular of 2,000 words, addressed to the American public. It details the condition of the Irish cause and plan of campaign of the Irish party, warmly indorses Mr. Parnell and extolls his leadership and appeals to the American people for financial assistance and moral support.

"The Original Package Dead." LITTLE ROCK, Ark., Nov. 1.—The opinion of Judge P. C. Caldwell, of the United States circuit court, in the original package case of H. M. Van Vled, of lowa, was filed yesterday. It discusses the questions raised and is very lengthy. The court in brief holds that the act of congress and the laws of the states are valid. After citing the act of congress and the state laws, the opinion concludes: "It is not the state laws but the original package that is dead." The judge denied Van Vled's petition for discharge from prison and remanded him to the custody of the state authorities in execution of the sentence imposed upon him.

Fire on a State Farm. NEW BRUNSWICK, N. J., Nov. 4 .- The The barns, silo, and cow stables of the New Jersey Agricultural Experiment station were burned, and 42 cows, 5 horses and 2 mules were destroyed. Thirteen of the cows were imported, and were worth \$800 each. They belonged to breeding associations and individuals. Only 14 cows, 2 bulls and 3 calves were saved. William Gordon, a farm hand, came near losing his life by being suffocated. The loss on the buildings is \$15,000; on stock, \$16,000; and on farm implements and other contents of the buildings, \$5,000. The loss is about half covered by insurance.

Governor Hill Wants a Recount. ALBANY, Nov. 1.—Governor Hill has sent a letter to Secretary Noble asking for a new census of New York city. In it he notes the difference between the federal census and the municipal census, and says that if all estimates are based upon fair standards of comparison they confirm the general inaccuracy of the count. The question of recount ceases to be local in its nature and involves seriously the rights of the state and perhaps in future the political control of the country.

Fighting Standard Oil. FINDLAY, O., Nov. 4.—The Manhattan Oil company, the strongest of the independent organizations in this field, boldly challenged the Standard to battle by advancing the price of Buckeye oil from 30 to 32 cents. All the other independent companies followed suit, and the Standard will probably meet the advance and a great oil war is now on. The excitement among producers and operators is already of an absorbing character.
