It is calculated that the number of immigrants who have come into the 21st. United States in the last hundred years in round numbers is 16,000,000, June 22nd. or the equivalent to one-fourth the present population of this country. June 23rd. Of this number nearly 5,000,000 were from Germany, 3,500,000 from Ireland, 1,500,000 from England, nearly 1,000,-000 from Sweden and Norway, and nearly 500,000 from Italy. Of the 16, 000,000 who have come fully 14,000,-000 were from Europe, 400,000 from British America and about 150,000 from other American counties. The Chinese immigration from 1855 to the time of its prohibition in 1882 amounted to about 265,000. Since the passage of the Chinese Exclusion act in 1882 the number known to have come in under the law is but about five large numbers have come in by devious methods in violation of the law.

> -A Contract for 250 Cars.

The Huntingdon and Broad Top Railroad will in a few days award a contract for 250 hopper-gondola cars of 60,000 pounds capacity, Pennsylva- oral. nia railroad standard, to accommodate its rapidly growing local trade. The coal tonnage of the company shows a gain of 25,000 tons during the past three weeks, and the general business has recently so increased that, notwithstanding a falling off in the coal tonnage in February, due to the depression in the coal trade, the net earnings were larger than ever before at that time of year. The company has now about 2,000 cars for its sixty-four miles of road.


