General Hastings has selected ex-Governor Beaver to make the speech nominating him for governor at the state Republican convention to be held in Harrisburg, May 23. Charles Emory Smith, editor of the Philadelder President Harrison, will make the seconding speech. Both are personal friends of General Hastings and have cheerfully promised to perform this service. There will be a number of parts of the state. One of these will likely be made by George B. Orlady, of Huntingdon county, who will be one of the delegates to the convention from there. Orlady is an eloquent talker and made the speech nominating Hastings at the state convention the nomination by a small majority. Hastings and Beaver have been associated together in politics and business for a generation. Both are residents of the town of Bellefonte and, when Beaver was elected governor eight years ago he appointed his fellow townsman his adjutant general. This was Hastings' induction into state politics and the first stepping stone to probable higher honors. He that followed the calamity which swept over that ill fated city in the summer of 1889, and won the sobriquet of "The Hero of Johnstown." 


Mountain Flies.
