HISTORY OF THE CRIME.

William Dillen was confined to the jail of Centre county, awaiting trial on a charge of assault and battery with intent to commit rape brought to No 34 August Session, 1904, at the time of the murder of Jerry Condo. Ira Green was confined, at the same time, in said jail, charged with larceny, the proceedings being brought to No. 21 August Session, 1904. In the former proceeding Anton Sakabosky was the prosecutor, and in the latter, Alice Pierson.





While Green was finishing the work begun by Dillen, the latter went to the bathroom and put on his shoes. In the meantime the jail keys were taken from Condo's person, given to George Livingston who unlocked cell No. 7, releasing Dominick Constance and George Henderson, after which the main entrance to the jail was unlocked, and there was a general jail delivery. Green and Dillen took with them in passing out of the jail the irons they had used on Condo, dropped them some distance from the jail, after they had passed all likelihood of meeting further resistance. The piece of iron incased in the stocking was matted with blood and gray hair, and it was admitted by the defendants on the trial that they had used these irons.



The Prisoners Recaptured.

After the five men emerged from the front door they passed around the north corner and out East High street. A number of persons saw them but did not know that they were fleeing from prison. Dominick Constance separated from them on the outskirts of town. The other four cut across the mountains, northward in the direction of Clarence. Out in Marsh Creek they sought food and inquired for the way to Renovo. They turned and came back and down towards Mt. Eagle, Tuesday were captured near Mill Hall, excepting Livingstone who left the party in the mountains and since was never heard of. THE TRIAL.

Soon after the arrests H. C. Quigley, was retained by the county to defend the prisoners. Later Clement Dale was retained by Ira Green, and Hon. A. O. Furst by Dillen. The prosecution was represented by District Attorney Spargler, Col. Edw. R. Chambers and Ellis L Orvis. Geo. Henderson and Dominick Constance, previously had been indicted of jail breaking and were convicted.

Geo. Henderson was indicted for the Julian robbery and jail breaking. He plead guilty and was sentenced to two years and eight months in the peniten-

Dominick Constance plead guilty to jail breaking, but on the charge of felonious arson, for attempting to burn David Rothrocks house, stood trial and was convicted. He was sentenced to four years in the penitentiary.

The trial of Ira Greene and Wm. Dil-

len came up Thursday, August 25th. The nature of the assualt was proven by inmates of the prison, also the threats against the life of Condo. When the prisoners took the stand they surprised all by admitting almost all that was proven. Their version was that Dillen carried the "T" iron, but struck Condo only with his fist and dropped the iron. Green admitted pounding the turnkey's head with the iron bar in the sock. Both disclaimed any intention of killing


