



A new trial had been denied the murderer and he was to be called before Judge Savidge during the present term of court and the death penalty imposed.

The engineers of the United States Coast Survey who mapped the coast of Long Beach for 12 miles south of Barnegat Inlet in 1839, found upon going over the ground in 1871 that the sea in 32 years had advanced inland an average of 545 feet for the entire distance, and in some places as much as 930 feet. Also they found that beginning at the mouth of Dennis Creek in Cape May County, the sea had swallowed 2,-310 feet of that stream and 1,880 feet of East and West Creeks. All this happened a generation ago.

STATE NEWS IN BRIEF.

Chicago-British War Office Has Every Confidence in the Stockyard Product. Another large contract for tinned

meats for the British Army has been placed with Libby, McNeill & Libby, of Chicago, through the Director of Supplies Department of the British War Office. This contract was a competitive affair, England, Canada, Australia and Brazil entering with tenders. It was quality and method of packing that got the Chicago firm the business. General Clayton, of the War Department, in an interview, according to the London Standard. stated that the British Government is highly satisfied with the foodstuffs supplied by Chicago, and they have every confidence in the manufactures entering Britain from the Stockyards. "The food for the Army will be packed under the supervision of British representatives at the invitation of the packers," he said, "although the Government is ready to rely upon the new Pure Food regulations recently inaugurated in the United States. All the talk about the inefficiency of the new law is sheer nonsense. British officers in America have gone fully into the matter and the authorities are perfectly satisfied to place orders in Chicago when conditions call for outside supplies of canned meats."
