Prof. Bruce Morris, of Rebersburg, was a guest at the home of John Meyer last Thursday.

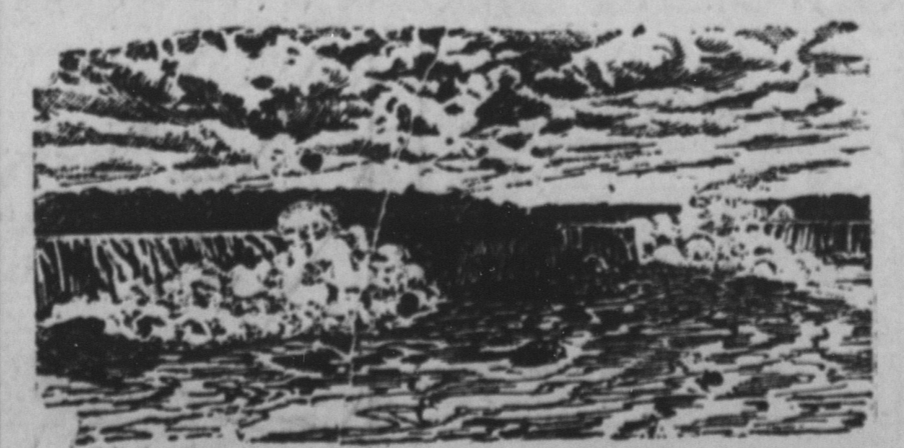
