George Douty, a brother of the deceased is also critically ill at his home with typhoid fever. Both young men contracted the disease while working on a saw mill.



Fourth Crop of Alfaifa.

Last week the fourth crop of alfalfa was harvested from a plat of eight and three-eighths acres, owned by the writer. The first crop yielded four two-horse loads, the second and third three loads, and the fourth crop two loads, or a total of twelve loads, which will equal between fourteen and fifteen tons of dry hay.

Another plat of three and threeeighths acres, seeded in August of last year, yielded eight two-horse loads, equal to between nine and ten tons of dry hay.
