Two Die in Electric Chair.

Two men were electrocuted at the Rockview penitentiary on Monday. The first was Peter Smolack, of Kulpmont, Northumberland county, who last summer while intoxicated killed his wife with a hatchet. He pleaded guilty and was sentenced to death without even the formality of a trial.

The second man was William Bush Brown, a southern negro, who killed Walter Moore at Woodland, Clearfield

county, in May 1918. His trial lasted less than one day. Both will be buried in the penitentiary cemetery, as the bodies were unclaimed.
