Centre County Public Health Assoc.
 As a representative of the Division of Communicable Diseases, State Board of Health, A. J. Bohl has been in Centre county for a few days making preliminary arrangements for the organization of the Centre County Public Health Association, which organization is to be of a permanent character and have for its head Dr. J. L. Seibert, of Bellefonte, county medical director. The scope of the work of the organization is to promote the general public health, especially stressing anti-tuberculosis and child welfare. Similar movements to form such organizations in every county in the State are being made, and will be under the direction of Charles H. Miner, Secretary of Health.

The time for organizing the association in Centre county has not been definitely fixed, but will likely be during the latter part of May or beginning of June.

Stryker, of Queen's Run, a former pupil at the Lock Haven Normal Training school, who had been trained during the past winter by a large motion picture corporation in Philadelphia, is spending his Easter vacation there. DEATHS

KRAMER—John Fishburn Kramer passed to the beyond on Monday evening at his home in Centre Hall, after an illness extending over the greater part of last winter. He was tubercular, but was hopeful until almost his last days that he would recover. Death came at an unexpected time to his household and friends.

Funeral services will be held Friday morning at 10:30 o'clock and will be in charge of Rev. S. F. Greenhoe, assisted by Rev. W. R. Picken, a near neighbor. Interment in the local cemetery.

Mr. Kramer was a son of Joseph (now deceased) and Mary Kramer, of Reading, and was born at Hershey, August 10th, 1882, making his age over forty-three years. His marriage to Miss Elsie Garis, who survives him, took place twenty years ago, and for eighteen years the couple lived in Centre Hall where Mr. Kramer was variously employed, his latter years having been devoted to building concrete walks, walls and cement building blocks.

Mr. Kramer's mother was at his bedside at the time of his death, and his three brothers and sister named below visited him quite recently. The brothers and sisters are: Harry P. of Schenango Forks, New York; Edward P. of Lebanon; William F. and Mrs. A. Mary Fair, of Reading.

Deceased was a member of Centre Hall lodge, I. O. O. F., and also of Lewistown lodge Fraternal Order of Eagles.

He was twice married, but both wives are now deceased. The funeral was held Monday afternoon, with interment at Millheim.

One brother, John Wolf, of near State College, also survives her.

Mrs. Breon suffered a severe attack of pleurisy some time ago, and never fully recovered. Her last sickness began with a bad cold, and later complications developed.

CORMAN—As the result of hardening of the arteries, John Corman passed away at the home of his daughter, Mrs. John Barr, at Coburn, on Sunday. The funeral services were held Wednesday. 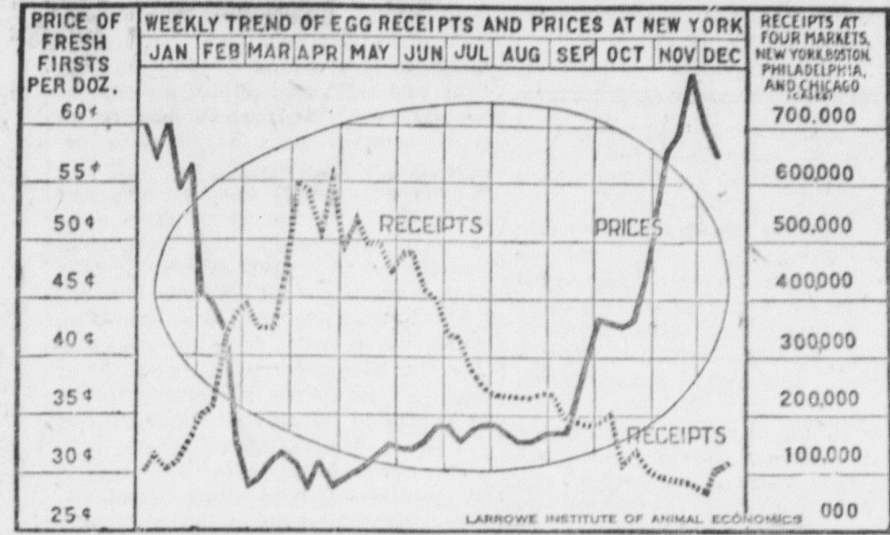
