AUTO AND WAGON COLLIDE.

Chester Patt, at Wheel, Dead—One Companion Badly Injured.

The collision of a horse-drawn wagon and an automobile resulted in the death of Chester Patt, aged 16 years, of Port Matilda. He was driving the car and with him were Theodore Engler, aged 24, on the front seat and Raymond Smith, on the rear. Engler was badly injured, while Smith was simply stunned.

The accident happened near the Miles picnic grove, near Martha, the car going west. The team of horses was being driven by Plummer Hoar, and with him was Domer S. Ishler, both of this place. They were coming from Altoona, to where they had delivered a load of Christmas trees, it having been one of several loads taken there. The collision was head on, the tongue of the wagon penetrating the radiator and into the car, striking the driver on the head. Both horses were injured and were killed later by shooting.

The three young men were taken to the Centre County hospital, where Patt died the following morning.

The team of horses belonged to Harry A. McClellan, of Tusseyville, and had been used by Mr. Ishler to make one or more of the previous trips to Altoona.
