DEATHS

RUNKLE.—John W. Runkle, Democrat, sheriff of Snyder county, died at his home in Middleburg on Saturday morning, two years ago he suffered a paralytic stroke, since which time his health has been failing. The deceased was a son of Daniel and Sarah Runkle, both deceased, and was born in Georges Valley seventy-four years ago. He engaged in the mercantile business at Fiedler, and from there went to Middleburg about thirty years ago, engaging in the same business. Four years ago he was elected sheriff of Snyder county. At the recent election his youngest son, Cyril Runkle, still in his twenties, was elected on the Democratic ticket to succeed his father in office, by a large majority.

Surviving the deceased are four sons and one daughter, namely: Carl, of Altoona; Calvin, of White Haven, Pa.; Keener, of Williamsport; Cyril, of Middleburg; and Mrs. George Witmer, of Sells Grove. Two brothers also survive: L. Calvin Runkle, of Shamokin, and Daniel Runkle, the deceased's wife, who was Miss Stallacher, of Fiedler, preceded her husband in death twenty-three years ago. Funeral services were held Tuesday afternoon, with interment at Middleburg.

YODER.—Mrs. Amanda Yoder, of Salona, widow of David Yoder, died at the Lock Haven hospital Friday night about 6:30. She was aged about seventy-seven years, and had been ill for some time. Mrs. Yoder is survived by three daughters: Mrs. C. C. Royer, of Locktondale; Mrs. W. H. Tyson, of Lock Haven; and Mrs. S. W. Saylor, of Sa-haven; three brothers and three sisters also survive: Fred Brungart, of Mifflinburg; William, of Muncy; Adam, of Rebersburg; Mrs. Harry Laubach, of Rocktown; Mrs. Emma Frazier, of Mill Hall, and Mrs. Alice Crouse, of Rebersburg. The body was taken to the home of Mrs. Saylor in Rebersburg Monday morning where funeral services were held Monday afternoon at 2 o'clock. Rev. W. O. Babch, of Salona, had charge of the services. Interment in the Cedar Hill cemetery.

SHULL.—Mrs. Mary Elizabeth Shull, widow of the late David Shull, died at the home of her son, Dr. O. M. Shull, in Millhelm, Wednesday morning of last week, after a very short illness of diseases incident to her advanced age. Deceased was one of two children born to John and Susanna Huey and was born in Northumberland county February 17, 1846, making her age at death 81 years, 8 months and 22 days. She was married to David Shull on December 6, 1866, and this union was blessed with seven children. Two of these have preceded the parents to the grave. Mr. Shull died five years ago. Surviving are these children: Ella, wife of G. W. Frankenberg, of Penn township; Sevilla, wife of A. G. Snook, of Oxford, Pa.; Al. Shull, of Clearfield; Harry E. Shull, of Dowagiac, Mich.; and Orvis M. Shull, of Millhelm.

SMULL.—George H. Smull, a well known real estate man, died at his home at Williamsport after a six weeks' illness of congestion of the lungs and nervous breakdown. He was 58 years old and was born at Rebersburg. His parents were Reuben and Louisa Smull. He is survived by his wife, who was Blanche Stover. They had no children and he had no brothers and sisters. The remains were taken to his former residence at Rebersburg and funeral services were held Wednesday morning from the home of Mrs. Smull's mother, Mrs. Chestie Smull, in charge of Rev. McClellan, of the Reformed church, and Rev. Baker, of the Evangelical church; interment in the Evangelical cemetery. Mr. Smull left Rebersburg about eight years ago.

HENRY.—Mrs. Calvin E. Henry, of Mingoville, met instant death by being thrown from an automobile driven by her husband as the car descended the mountain above Tyersville. The couple had been at Rebersburg and on going down the mountain the brakes refused to function. Mrs. Henry was a daughter of Mr. and Mrs. John Lutz and was a native of Tyersville. She was aged 74 years, 2 months and one day. Besides her husband, who is well known in Centre county, three children survive: John, whose address is unknown; Mrs. Henry Hoy, of Pleasant Gap; Albert, of Mingoville; Mrs. John C. Casselin, of Mill Hall; Miss Edith, of Pittsburgh; Grover and Robert, at home.

Funeral services were held at the Hubbardburg Evangelical church; interment in the little cemetery adjoining the church.

Port Matilda Man Killed.

Michael C. Walk, of Port Matilda, aged 82 years, died at the Mercy hospital in Altoona at about 1:30 Monday morning the result of a possible fractured skull, a fractured forearm and a lacerated forehead received in an automobile accident. Mr. Walk was injured when struck by an automobile as he was alighting from another car in front of the home of his son in Dix, near Port Matilda, Sunday evening. Mr. Walk had accepted a lift to get to the Dix home. He stepped from the car and started across the road, directly into the path of another car, which struck him and knocked him to the road.

In the excitement of the moment the name of the driver was not learned, although he is said to be from Jersey Shore.

Public Sale of Cows.

Brigadier General Frank R. McCoy, of the U. S. Army is being boosted as the successor of General Leonard Wood in the Philippines. COMMENT ON THE ELECTION.

Democrat Tells How His Party Lost Judgeship — Phillipsburgers Have Held Number of Important Offices In Past.

[Phillipsburg Journal.] "The Democrats of Centre county lost the judgeship by a mere handful of votes because no concerted effort was made to get out the Democratic vote in Phillipsburg district," declared a well known local member of the party in commenting on the election. "In each ward in Phillipsburg there were Democrats who did not vote. The same condition prevailed in the nearby election precincts. The few faithful workers on hand, with but a few automobiles at their disposal but part of the time, could not reach all the different and careless party members.

"Coupled to this defection was the assistance given the opposition by some of the local leaders of the party. It is all right for them to vote their choice at the election. That is every citizen's right. But after these leaders have taken part in the Democratic primaries, and have been honored by their party in one way or another, it ill becomes them to take off their coats and almost work their heads off for the opposition. That sort of thing has been going on in the Phillipsburg region for several years."

Judge-elect Fleming is the first resident of Phillipsburg to be elected presiding officer of the Centre county courts since the county was incorporated 127 years ago. So far as can be ascertained no resident of Phillipsburg ever before sought nomination and election to the judiciary.

In fact, Phillipsburgers have not fared so badly at the hands of the voters of the county. The late Chester Munson, of Phillipsburg, was elected associate judge of Centre county, and the same honor at another time was bestowed upon Corlis Faulkner, long deceased. The office of associate judge was later abolished. Messrs. Munson and Faulkner were both Democrats, as was the late Levi Munson, another Phillipsburg resident, elected sheriff of the county. George W. Rumberger, now living at Unionville, and who is in his ninety-first year, was a resident of Phillipsburg for a number of years, and was elected register of the county for two terms while living here. He, too, is a Democrat.

Centre county voters elected P. E. Womelsdorf, Phillipsburg, Republican to the Legislature, and the same honor was twice bestowed upon Harry B. Scott, Phillipsburg Republican, who is now serving as State senator from the Centre-Clearfield district. The late Charles H. Rowland, while a resident of Phillipsburg, was twice elected a member of the federal congress. He was an ardent Republican. Roy Wilkinson was a resident of Phillipsburg when first elected prothonotary of the county eight years ago. He was re-elected and came near being elected for a third term at the recent election. He has always been a strong Republican.

The above enumeration of local office holders indicates that Phillipsburg candidates in both parties have not been wholly neglected.

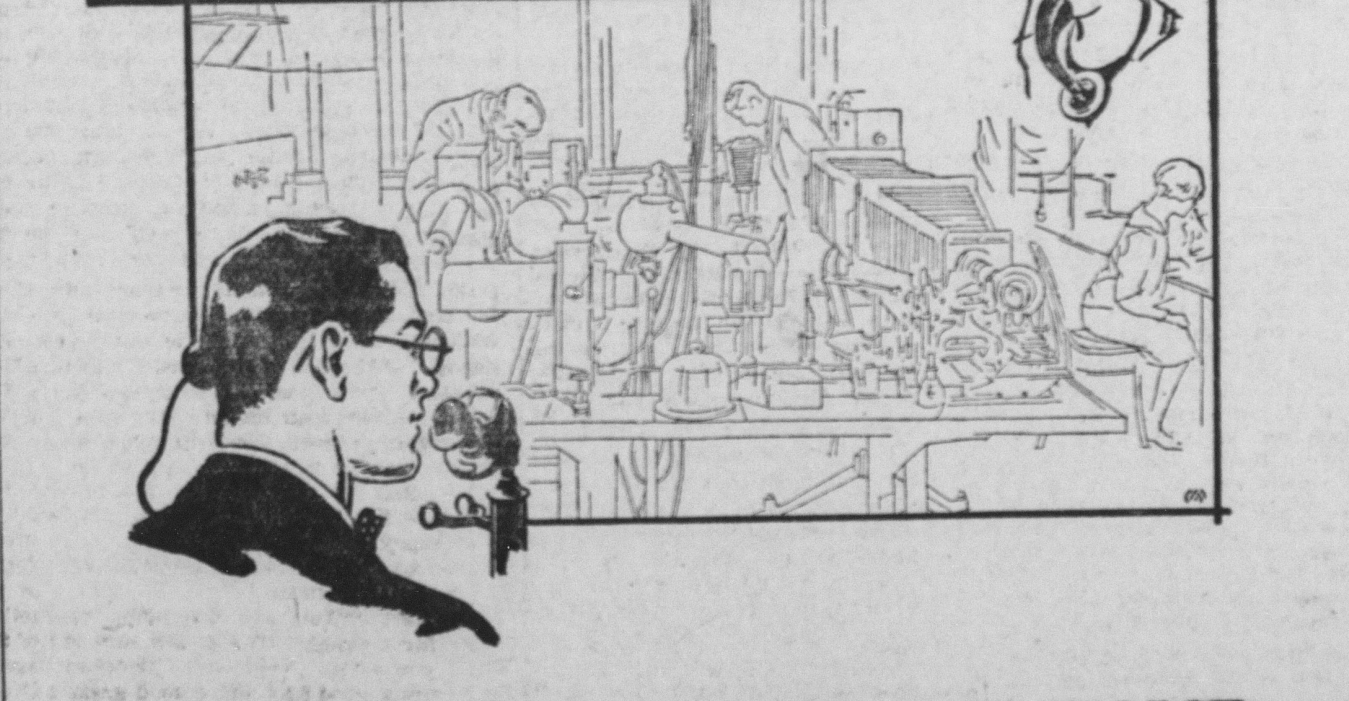
