FARM CALENDAR.

Timely Reminders From The Pennsylvania State College. PREPARE FOR STORAGE—If you plan on storing grain it will save money to inspect and repair the granaries now. Eradicate the common grain robbers, rats, which is not such a hard job. Shoot calcium cyanide into the holes with a dust gun. The rats will die in these hiding places or will be so overcome that they are easily killed when they emerge. TEND TO ROSES.—Roses will need attention this month. Discourage a too heavy cane growth by pinching the tips of the shoots. Keep all the old canes cut out and remove all dead mulch well during the hot weather. Grass clippings will be good for this purpose. WATCH SUMMER FEEDING.—Do not take the haying mash away from the cows. It will check production and delay early milking. Keep plenty of clean water in front of the flock at all times.

She was a daughter of Charles and Lydia Ripka, late of Gregg township, deceased. She is survived by her husband and a daughter, Mrs. William McClintic, of Linden Hall, a granddaughter and five grandsons. Also, a brother, Samuel Ripka, of Millheim, and three sisters—Mrs. Susan Crater, Port Clinton; Mrs. Julia Malize, Millheim, and Mrs. Elmira Decker, Millroy. Interment was made at Centre Hall on Tuesday afternoon after services held at the home by Rev. W. E. Smith, pastor of the Evangelical church, assisted by Rev. S. F. Greenhoe, of the Lutheran church. Mrs. Tressler had been in poor health for a long time. About a year ago she was a patient in the Centre County Hospital and improved. Last winter she fell and broke her arm and since then her condition had not been favorable, although for most of the time she was able to take care of herself. On Thursday morning of last week she was unable to leave her bed, growing weaker until the end came.
