Laurelton Man Injured on Nittany Mt.

Carl Von Neida, of Laurelton, is in a serious condition in the Centre County Hospital following an automobile accident Saturday night, on Nittany Mountain, a short distance from Centre Hall. According to reports, Mr. Von Neida was driving down the incline of the mountain, and was attempting to pass another car when his machine skidded and crashed into a concrete abutment. He was tossed from the car by the force of the impact. Two occupants of the car were uninjured. He suffered five fractured ribs, and possible internal injuries.

Sunbury Brakeman Wins Hero Medal for Saving Child.

Samuel E. Osman, of Sunbury, a brakeman, and five other employees of the Pennsylvania Railroad company were presented with heroic service medals a few days ago. General W. W. Atterbury, president of the company, presented the awards as a ceremony in the board room of the Broad Street Station, Philadelphia. Mr. Osman, who is a son of the late Calvin Osman, of Glen Iron, and a brother of Mrs. J. Fred Slack, near town, saved the life of a 2-year-old boy near Pardee, on November 18, 1928. As a local train approached Pardee, on the Lewisburg and Tyrone branch, the engine crew saw what was supposed to be a dog on the track ahead. A few seconds later the engineman realized a child was sitting on the end of a cross-tie. Although he applied the emergency brakes, it was apparent the train could not be stopped short of the child. Osman, who was sitting in the cab, made his way to the pilot, jumped off and ran ahead of the engine. He pecked up the child and stepped off the track just in time to avoid being struck by the cylinder head. When Mr. Osman leaped off the pilot the train was moving at the rate of about eight miles an hour. The train was stopped with the front end of the tender over the cross-tie on which the child had been sitting. The child is the son of Mrs. Irene Jailer, of Wolfert.

VONEIDA.—Elizabeth Gramley Voneida, sister of the late Simon P. Hennigh, of Centre Hall, with whom she made her home some few years ago, died on Friday, Feb. 21st, at Hershey, aged 73 years, 6 months and 10 days. She was born a few miles south-east of Centre Hall, a daughter of David E. Hennigh. Her first marriage was to Francis Gramley, of Loganton. Four children survive to this union: Mary Bates, of Pittsburgh; Lula Packler, of Mill Hall; George F. of Altoona, and Bessie J. Tibbens, of Loganton. Mr. Gramley passed away at Loganton some years ago, and after his death Mrs. Gramley made her home among her children and with her brother in this place, until six years ago when she again married, this time to Robert Voneida, of Reading. The couple lived at Hershey. Deceased suffered a long illness from stomach trouble and gall stones, but consumption was pronounced the real cause of her death.

The body was conveyed to Loganton and burial made in the Evangelical cemetery there on Monday of last week. Rev. A. C. Paulhamus, pastor of the Evangelical church, delivered the funeral sermon in that church.

KAUFFMAN.—John Kauffman, aged 79 years, a native of Centre county, died at his home in Zion, Saturday night at 10:30 o'clock, following a brief illness with a complication of diseases. He was born at Zion and was the last surviving member of the Kauffman family. He was a farmer until a few years ago when he retired.

Funeral services were held at his home Tuesday morning at 10 o'clock, conducted by Rev. Paul Keller, pastor of the Reformed church at Snyderstown, assisted by Rev. Harry Hartman, pastor of the Reformed church at Zion, and burial was made in the Zion cemetery.

POTTS.—Miss Jennie Potts died at Stormstown Wednesday noon of last week, at the age of 83 years, 6 months and 1 day, following an attack of acute indigestion.

Deceased was born near Stormstown, and lived all her life in that immediate vicinity. Her parents having died when she was quite young she is survived by an only brother, Green Potts. She was a member of the Methodist church, the pastor of which had charge of the funeral services Saturday afternoon at 1:30.

RESIDES.—William S. Resides, aged 86 years, died at his home in Bellefonte, at 2 o'clock Friday morning, as the result of complications incident to old age. He was born in Buffalo Run Valley and was a carpenter by trade. He spent practically all his life in Bellefonte. He is survived by his wife and also one sister, Mrs. William Sellers, of Pittsburgh. Funeral services were held at his home Monday afternoon, in charge of Rev. Homer C. Knox, and burial made in the Union cemetery.

DAVIS.—Miss Effie Davis, wife of Charles Davis, died at her home at Koppel, Beaver county, of diabetes, aged 55 years.

Interment was made at Koppel. Deceased was a daughter of Mr. and Mrs. Henry Kresmer, former residents of Aaronsburg. She was united in marriage to Mr. Davis, who survives with four sons and one daughter—William, Emory, Floyd, Paul and Margaret Davis; also four brothers—Lloyd, of Pittsburgh; Paul, of Butler; Roland, of Millroy; and Harry, of Coburn; three sisters—Mrs. Daniel (Maude) Breon and Mrs. Sara Livingston, both of Jeanette, and Mrs. Aaron Zerby, of Illinois, and her father.

GRENOBLE.—Mrs. Bessie Grenoble, wife of Robert R. Grenoble, a jeweler, passed away very suddenly at her home in Lewisburg. She was in ill health for the past several years suffering from a heart ailment. Her condition was thought to be improving and her sudden death came as a severe shock to the members of the family as well as to the community where she was well and favorably known.

The circumstances surrounding her death are particularly sad, as four small sons survive in addition to her husband, who is a son of the late John Grenoble, of Spring Mills. The oldest boy is 12 years, while the youngest is only 2 years old. The deceased, before marriage, was Miss Bessie Giboney, a native of Yeagertown. She was aged 37 years.

Frozen Feet Amputated.

A pathetic and extremely unfortunate operation was performed on John Gill, of Philipsburg, Saturday morning, March 1, at the Philipsburg State hospital, when it was necessary to amputate both feet above the ankles. On Sunday, February 9, when the temperature was below zero Mr. Gill had his feet frozen and was taken to the Philipsburg State hospital for treatment. It was found necessary, finally, that the members be amputated, although everything possible was done to avoid it. Mr. Gill, aged about 45 years, has been employed by the Philipsburg borough on the streets of the town for a number of years, previously working at the brick yards.

The Philadelphia Inquirer Sold.

The Philadelphia Inquirer passed into the hands of the Curtis-Martin Newspapers, Inc., by the purchase by that corporation of more than fifty per cent of the stock. The Inquirer building was purchased outright. Its value alone is placed at \$10,000,000. The estimated value of the Inquirer stock shares is \$14,000,000.

First Debate, March 11.

The first of the County Debates in which Centre Hall is competing will take place on Friday, March 11. The question, which was selected by the State Forensic League, is Resolved: That the county should be the unit of support and control of public schools. This question has been considered in educational circles for some time and the county unit has already supplanted the district and township school systems in some States. In Pennsylvania, however, it is a relatively recent problem.

The Gregg Township Vocational School negative team will meet the Centre Hall High School affirmative in the Centre Hall High school building in the first debate; and the Centre Hall High School negative team will travel to East Penns Valley High School and oppose the affirmative team of that school. On the following Friday, March 21, the affirmative teams will travel, instead of the negative.

The teams in the local High school are: Affirmative, Wanda Brown '31; Agnes Cummings '31; and Adaline Dinges '32; negative, Evelyn Bradford '30; Hugh Morrow '33; and Walter Wilkinson '30.

Last Thursday afternoon the debaters visited the Carnegie Library at State College for the purpose of finding statistics on the question for debate.

WAGNER FARM SOLD

BACK TO HAROLD MUSSER

The Bernard Wagner farm, near Centre Hall, for many years rated as one of the largest and most productive farms in Potter township, was sold back to Harold Musser, of Millinburg, a grandson of Mrs. Hulda Meyer and the late Wm. H. Meyer. Since the death of the latter the farm in question has been sold several times and under varied circumstances. It was finally decided to the eldest of two grandsons, the only heirs, Mrs. Musser sold the farm to Harry P. Shirk, of Millin county, who has been living on it for several years. The consideration in the deal is but \$2000. This, however, does not represent the true value of the farm.

Millin County Expenses Grow \$80,000 In Year.

In 1928 the expenses of Millin county jumped \$80,000 over the previous year, but the report of the county auditors for 1929, just made public, shows that there was reduction of \$19,532 from 1928, the reduction being made in the expenses for assessors' pay, cost of bridges, books, probation officers, elections and costs of prisoners.

The total expenses for 1929 amounted to \$249,074.66, while the 1928 expenses totaled \$269,290.15. The liabilities of the county amount to \$337,532, of which \$280,000 is the bond issue for the Memorial bridge over the Juniata river. Nineteen thousand dollars was placed in the sinking fund for the retirement of the bond issue.

Thirty-four thousand and fourteen dollars was paid toward the cost of the construction of the new county courthouse in 1929, while among the larger expense items were: Lunacy, \$11,046; prisoners, \$8279; maintenance of poor, \$44,650; court expenses, \$14,046; assessors' pay, \$5524; county officers' pay, \$8632; sheriff and jailer, \$7521.

Historical Events.

Snyder county's historical society is making plans for two important events this season. The first is the marking of the Albany treaty line through Monroe township, in June. The second is the celebration of the 175th anniversary of the Penns Creek massacre which occurred October 16, 1775. On that day a band of Indians who had come down from the headwaters of the Susquehanna and through Centre county into Penns Valley, attacking the settlements, massacred 18 settlers in Penns Creek and carried 10 others away in captivity, from which some of them later returned to the settlements. The massacre is linked with the French and Indian wars.
