DEATHS.

MILESBURG HUNTER DIES DURING DRIVE

Acute Indigestion or Heart Attack Believed Responsible for Demise of Harry D. Weaver, Found By Companion on Top of Snow Shoe Mountain.

Harry D. Weaver, aged 43 years, one of a party from Milesburg who had gone to Snow Shoe mountain on Monday to hunt, was found dead on top of the mountain by a companion about 4 o'clock that afternoon. Members of the party had missed him, and organized a search.

Before leaving home with ten companions, Mr. Weaver had complained of indigestion, but seemed in his usual health after arriving at the woods. They hunted during the morning and at noon ate dinner at a lunch place on the Snow Shoe mountain.

Shortly after the beginning of the afternoon drive his companions missed him, and started a search. About 4 o'clock his body was found on the top of the mountain by Malcolm Wetzler, of Milesburg. A physician summoned stated that death evidently resulted from acute indigestion or a heart attack.

He is survived by his wife, Mrs. Minnie Weaver; his mother, Mrs. Ida May Weaver, of Colyer; his sister, Mrs. Ray Decker, and his grandmother, Mrs. David Fye, all of Colyer. The funeral will be held this (Thursday) afternoon, a short service at the home at 1 o'clock to be followed by a service at the Zion Evangelical church at Colyer. Rev. M. C. Piper will officiate and burial will be made at Tusseyville.

The deceased was employed as a tower man on the Bald Eagle railroad.

SMITH.—Dr. Calvin F. Smith died at his home in Indianapolis, Indiana, where he practiced his profession for many years, on Tuesday of last week. Interment was made in that city Saturday afternoon.

The deceased was a son of Peter and Julia (Neese) Smith, and was born at the Custer hotel stand, east of Lamar. He accompanied his parents to Centre Hill when they moved there about 1870. He attended the township schools and later the Penn Hall Academy, and then took up the study of medicine, desiring to follow the footsteps of his grandfather, the late Dr. Charles Smith, who practiced his profession for many years in Penna Valley, Freeburg and later in Pittsburg. He graduated from a Philadelphia medical school and began giving service in his profession at Howard, where he married. A few years later, about 1890, he went to Indianapolis, where he soon obtained a lucrative practice. He invested his surplus cash in real estate which increased handsomely in value. He also acquired the Peter Smith homestead at Centre Hill and the Neese homestead at Penn Hall, retaining them to the time of his death.

There survives him a daughter, Mrs. Julia Peacock, of Cleveland, Ohio, who was with her father at the time of his death.

SECHRIST.—The body of the Rev. James R. Sechrist was taken to Red Lion, York county, on Friday for interment in the Sechrist family burial plot. Rev. Mr. Sechrist, who was at one time pastor of the Evangelical circuit and resided in Lock Haven, died at the home of his daughter, Mrs. Stella V. Williams, at Howard, Thursday, after 15 minutes' illness of heart disease. He was born in Penton, York county, in 1852, and had served in the ministry of the Evangelical church for 55 years, retiring in 1921 from active ministry. Surviving him in addition to his daughter with whom he resided are one son, Hensel, of Los Angeles, Cal., and four daughters, Mrs. John H. Haberstroh, of Lock Haven; Mrs. F. C. Edmonds, of New York City; Mrs. Mabel Dyerling, of Hollywood, Cal., and Mrs. Ethel Gardner, of Harrisburg, and one brother, Stephen, of Red Lion, York county.

Rev. Sechrist was pastor of the Evangelical church here about twenty-five years ago. At that time all of his children, except Mrs. Williams, were at home.

ROYER.—Impaired health from overseas service during the World war claimed the life of Clyde Royer, 41 years of age, in his family home at Bellevue, Ohio, Thursday night, November 29th.

Mr. Royer, a son of Mr. and Mrs. Harvey Royer, was born January 18, 1889, in Centre Hall, and at the age of 11 years went with his parents to Bellevue, Ohio. He was united in marriage January 1, 1917, to Miss Amelia Stutz, of Gibsonburg, and in May, 1917, entered the service of the United States as a soldier.

During his overseas service he spent six weeks in a French hospital and since his return has been afflicted with rheumatism and heart trouble, a complication which eventually caused his death. At the time he was stricken with his fatal illness he was an employe of the assembly department of the Ohio Cultivator Co.

He was a member of St. John's Lutheran church, and of the Bellevue society of Eagles.

Surviving are his parents, Mr. and Mrs. Harvey Royer, his widow, one daughter, Gertrude, a number of other relatives and many friends.

Interment was made at Bellevue.

MOORE.—Edward Moore, of Boalsburg, died Friday of last week at the home of his daughter, Mrs. Boyd Ripka. Mr. Moore had been failing in health for several years, and about a week before his death took pneumonia which was more than his weakened physical condition could throw off. Mr. Moore had been a farmer all his life. He had been raised in the home of John Mitchell near Pine Grove Mills. He was rewarded for his faithfulness to Mr. Mitchell in a gift of

the farm just west of Pine Grove Mills, where he spent the remainder of his life until about a year ago when he rented his farm and moved into the town of Pine Grove Mills. He was a good citizen and a member of the Presbyterian church.

There survives to mourn his departure a wife and three children, namely: Mrs. Moore, Mrs. Ripka, Mrs. Bhorst, of Pine Grove Mills, and John Moore, somewhere in West Va. On account of sickness the son was not able to get home for the funeral. The services were held in the Presbyterian church at Pine Grove Mills, and the burial in the Pine Grove Mills cemetery. The Rev. Walter K. Harnish of Sinking Valley, preached the funeral sermon. Mr. Moore will not only be missed by his family but also in the Sabbath school and church. Mr. Moore's family were Lutheran. His wife's pastor, the Rev. Mr. English, assisted in the services.

He lived both long and patiently. His life work was not fun; We hope in his departing We heard the words, "Well Done."

BROWN.—Mrs. Margaret Brown, widow of David I. Brown, former resident and tinsmith in Millheim, died at the home of her daughter, Mrs. C. A. Reed, in Williamsport, after an illness of a tubercular nature over a period of several years.

Mrs. Brown was a daughter of the late Jacob and Matilda (Gulse) Eisenhuth and was born in Millheim about 76 years ago.

Following her marriage to Mr. Brown, the couple resided in Millheim for a while, but for the past 39 or 25 years had made their residence in Williamsport. Mr. Brown died ten or twelve years ago.

Surviving are a son and four daughters; also a sister, Mrs. P. H. Musser, of Millheim.

Funeral services were held Wednesday afternoon of last week and interment made in East Wildwood cemetery, Williamsport.

KREBS.—Miss Annie H. Krebs passed away at the Mercy Hospital at Altoona after a year's illness of cancer. She was a daughter of David and Rachel Royer Krebs, and was born near State College, Feb. 14, 1879. She was aged 51 years, 8 months and 16 days. She spent the early years of her life with the A. F. Markle family at State College and her later years with the H. A. Grubb family near Pine Hall. Surviving are three sisters: Mrs. Hannah Hoy, Mrs. B. E. Bloom and Miss Emma Krebs, all of State College. She was a member of the Lutheran church. Funeral services were held at the Pine Hall Lutheran church, conducted by Rev. J. E. English; interment in the cemetery adjoining the church.
